ORDINANCE NO. 081-2020 (Comm of the Whole – 1st reading – ADOPT 10/20/2020–?/?)

AUTHORIZING ADOPTION OF THE NOVEMBER 2020 REPLACEMENT PAGES TO THE CODIFIED ORDINANCES OF THE CITY OF WHITEHALL, AND DECLARING AN EMERGENCY.

WHEREAS, it is desirable and necessary that the City of Whitehall maintain an organized and published code of ordinances; and

WHEREAS, the codified ordinances for the City of Whitehall should be amended regularly to conform with current state law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by council and should be included in the codified ordinances; and

WHEREAS, the Walter H. Drane Company of Cleveland, Ohio has entered into a contract with the City of Whitehall to prepare and publish such revisions twice a year and the November 2020 replacements are now before council; NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

- <u>SECTION 1</u>. That the ordinances of the City of Whitehall, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the November 2020 replacement pages to the codified ordinances are hereby approved and adopted.
- <u>SECTION 2</u>. That the President of Council and Clerk of Council shall certify that the permanent and general ordinances of the City, as codified in the current replacement pages are correctly set forth therein.
- SECTION 3. That the City Auditor is hereby authorized to draw his warrant upon the Treasurer of the City to pay the Walter H. Drane Company for said services and products from previously appropriated monies in the City Council Office Supplies Account (101-100-52000).
- <u>SECTION 4</u>. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety and welfare; and for the further reasons that it is necessary that the City of Whitehall maintain an organized and published code of its ordinances and that it conform with current state law

MAKING A SUPPLEMENTAL APPROPRIATION OF FORTY THOUSAND EIGHT HUNDRED FORTY-TWO AND 33/100 DOLLARS (\$40,842.33) FROM THE TAX INCREMENT FINANCING FUND (279) TO VARIOUS EXPENSE ACCOUNTS IN THE 279 FUND AND AUTHORIZING THE DISTRIBUTION OF THE PORTION OF THE TOTAL SERVICE PAYMENTS ATTRIBUTABLE TO EACH TIF TO THE AFFECTED VOCATIONAL SCHOOL DISTRICT FROM THE TAX INCREMENT FINANCING FUND (279) IN THE AMOUNT EQUAL TO 100% OF THE PROPERTY TAX PAYMENT THE VOCATIONAL SCHOOL DISTRICT WOULD HAVE RECEIVED OF FORTY THOUSAND, EIGHT HUNDRED FORTY-TWO AND 33/100 DOLLARS (\$40,842.33) AND DECLARING AN EMERGENCY.

WHEREAS, in September 2020, the City of Whitehall received the 2020 second half TIF tax year distribution; and

WHEREAS, the city received its share of TIF funds as well as TIF funds that shall be paid to the affected vocational district; and

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

SECTION 1: This Council does hereby find and determine that it is in the best interest of the City of Whitehall to ensure that the vocational school system benefit of the distribution of service payments which can come from the use of tax increment financing incentive (TIF) districts.

WHEREAS, the City of Whitehall collects fees for inspections, permits and plan reviews; and

WHEREAS, the City of Whitehall has to pay these fees to various vendors; and

WHEREAS, there is a need to increase the appropriation to keep up with the work being done in the City; and

SECTION 1: Approving and making a supplemental appropriation of one hundred thirty-six thousand and no/100 dollars (\$136,000.00) from unappropriated monies in the Inspection Deposit Fund (804) to the Inspection Deposit Account (804-000-50000).

<u>SECTION 2:</u> That the City Auditor is hereby authorized to draw his warrant upon the Treasurer of the City for the purposes stated in this Ordinance.

SECTION 3: That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety and welfare and for the further reason that it is necessary to have the monies available to pay these expenses; WHEREFORE, this Ordinance shall go into full force and effect immediately upon its passage and approval by the Mayor.

## ORDINANCE NO. 088-2020 (Admin/Fin. Mgmt. – 1st reading – ADOPT 10/20/2020–Bailey/)

ESTABLISHING THE CITY OF WHITEHALL COVID-19 BUSINESS GRANT PROGRAM, APPROPRIATING \$100,000.00 FROM THE CARES ACT - FRANKLIN COUNTY FUND, AND DECLARING AN EMERGENCY.

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136 (the CARES Act) was signed into law by the President of the United States on March 27, 2020;

WHEREAS, the Ohio General Assembly established a process for distributing funds provided by the CARES Act in House Bill 481 ("HB 481") of the 133rd General Assembly; and

WHEREAS, the City of Whitehall has received \$100,000.00 in distributions from the State of Ohio and, pursuant to Ordinance Number 087-2020, the Council of the City created Special Revenue Funds to account for the funds received under these distributions; and

WHEREAS, the 133rd Ohio General Assembly passed Senate Bill 310 ("SB 310"), which permits a political subdivision to utilize all or a portion of the funding received under HB 481 for the purposes of establishing a small business grant program; and

WHEREAS, SB 310 requires the Council of the City of Whitehall to adopt an ordinance or resolution to create the small business grant program, which sets forth the form and manner by which qualifying businesses may apply for and receive grants, the standards for evaluating and prioritizing grant applications, the reporting requirements for qualifying businesses that are awarded grants, and the manner in which unspent and/or improperly spent proceeds are to be repaid by a grant recipient; and

WHEREAS, Council has elected to create the City of Whitehall COVID-19 Business Grant Program. NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

<u>SECTION 1</u>: That Council hereby authorizes the issuance of grants from the proceeds received by the City from CARES Act Funds to be issued to local businesses directly impacted by COVID-19.

<u>SECTION 2</u>: That the Director of Economic Development and Public Service shall establish the City of Whitehall COVID-19 Business Grant Program, utilizing the application attached to this Ordinance, and engage in efforts to inform the business community of the City of the application process.

<u>SECTION 3</u>: That grant funding from the City of Whitehall COVID-19 Business Grant Program shall only be available for eligible expenses incurred between the period of March 1, 2020 until August 31, 2020.

SECTION 4: That any grants approved for small businesses directly impacted by COVID-19 shall be used only for permitted purposes as set forth in the CARES Act and SB 310 and shall be subject to audit and oversight by the Director of Development, City Auditor as well as the Ohio Office of Budget and Management.

SECTION 5: That the amount of \$100,000.00 shall be appropriated to account number 205.000.53000, Miscellaneous distributions from the CARES Act- Franklin County Fund (203), to finance the City of Whitehall COVID-19 Business Grant Program.

SECTION 6: That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety and welfare and for the further reason that it is necessary to assist local businesses as soon as possible and meet State and federal deadlines; WHEREFORE, This Ordinance shall go into full force and effect immediately upon its passage and approval by the Mayor.

## RESOLVING TO APPROVE "THEN AND NOW" CERTIFICATES AND DECLARING AN EMERGENCY.

WHEREAS, O.R.C. 5705.41(D)(1) states that "then and now" certificates of three thousand dollars and no/100 (\$3,000.00) and more must be approved by resolution or ordinance within thirty days of receipt of the "then and now" certificate, and

WHEREAS, the City has determined that it is in the best interests of the City and its Residents that the City arrange for the guaranteed acceptance and processing of all Recyclable Materials generated at Residential Units and Municipal Facilities and during Special Events located within the City from a single Contractor on an exclusive basis ("Recycling Services"); and

WHEREAS, on January 30, 2020 and on February 6, 2020, the City, as part of a Joint Bidding Process with communities located within the jurisdiction of the Solid Waste Authority of Central Ohio ("2020 Solid Waste Consortium"), invited through advertisement in the Daily Reporter qualified providers of the Recycling Services to submit bids to provide Recycling Services on the terms and conditions contained herein; and

WHEREAS, the Contractor owns, operates or has reserved capacity available at a properly licensed and permitted material recovery facility or Legitimate Recycling Facility for the processing of Recyclable Materials, known as Rumpke's Columbus MRF, and located at 1191 Fields Avenue, Columbus, Ohio ("Identified Facility"); and

**WHEREAS**, the Contractor submitted a Bid to become the sole provider of Recycling Services for Recyclable Materials generated at Residential Units and Municipal Facilities and during Special Events located within the City; and

WHEREAS, the City has accepted and awarded a separate contract to a Collection Contractor, for the collection, transportation and delivery of all Recyclable Materials generated at Residential Units and Municipal Facilities and during Special Events located within the City; and

**WHEREAS**, in reliance upon the Contractor's Bid, the City requires that the Collection Contractor deliver all Recyclable Materials to the Contractor's Identified Facility for processing by the Contractor; and

**WHEREAS**, the City desires to accept the Contractor's Recycling Services Bid and engage the Contractor to be the sole provider of Recycling Services; and

WHEREAS, pursuant to the Collection Agreement, the Collection Contractor shall pay all tipping fees on behalf of the City to the Contractor for the acceptance and processing of Recyclable Materials in such amounts as provided in the Bid Form attached hereto as Exhibit C and incorporated herein by reference; and

**WHEREAS,** the City and the Contractor each represents that it has the authority to execute this Agreement for the Recycling Services.

WHEREAS, Miami-Dade County, Florida is a Lead Agency of the National Intergovernmental Purchasing Alliance Company, a Delaware corporation d/b/a OMNIA Partners, Public Sector and/or Communities Program Management, LLC, a California limited liability company d/b/a U.S. Communities (collectively," OMNIA Partners"), a provider of public sector cooperative purchasing programs with no annual fee for government-entity members, which provides access to competitively solicited and publicly-awarded contacts

WHEREAS, upon reviewing the cart manufacturing and delivery bid from Rehrig Pacific Company among others available through joint purchasing cooperatives, the City determined that Rehrig Pacific Company is qualified and submitted the best quote to provide Garbage Collection Container Manufacturing and Delivery Services to the City; and

WHEREAS, to finance the purchase of 5,600 carts in an amount not to exceed \$262,620, the City has selected Rehrig Financial Services to provide Financial Services to the City of Whitehall. As part of this finance agreement, semi-annual installments of no more than \$29,292.98 will be made in arrears over a 60-month term; and
