ORDINANCE NO. 096-2020 (Admin/Fin. Mgmt. – 1st reading – ADOPT 11/03/2020–Bailey/)

AUTHORIZING THE CREATION OF THE JEFFERSON TOWNSHIP-WHITEHALL JEDD FUND (830), APPROPRIATING FORTY THOUSAND AND NO/100 DOLLARS (\$40,000.00) FROM UNAPPROPRIATED MONIES IN THE JEFFERSON TOWNSHIP-WHITEHALL JEDD FUND (830) TO THE JEFFERSON TOWNSHIP-WHITEHALL JEDD EXPENSE ACCOUNT (830.000.50000) AND DECLARING AN EMERGENCY.

WHEREAS, the City of Whitehall, Ohio (the "City") and Jefferson Township, Franklin County, Ohio (the "Township") entered into a Jefferson Township-Whitehall Joint Economic Development District Contract (the "Contract") to create and provide for the operation of the Jefferson Township-Whitehall Joint Economic Development District (the "District") in accordance with R.C. 715.72 for their mutual benefit and for the benefit of their residents and of the State of Ohio (the "State"); and

WHEREAS, Whitehall City Council approved the Jefferson Township-Whitehall Joint Economic Development District contract per Ordinance 001-2020; and

WHEREAS, the City needs to hold these funds in an agency fund for tracking purposes; and

WHEREAS, certain that this account will have deposits received directly or by transfer during the calendar year 2020 thereby requiring an appropriation before disbursement for the intended purpose and requiring that monies be appropriated at this time; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

SECTION 1: That the Council of the City of Whitehall approves the creation of the Fund (208).

SECTION 2: That the Council approves the creation of the Jefferson Township-Whitehall JEDD Expense Account (830.000.50000) and makes an appropriation of forty thousand and no/100 dollars (\$40,000.00) from unappropriated monies in the Jefferson Township-Whitehall JEDD Fund (830) to the Jefferson Township-Whitehall JEDD

Expense Account (830-000-50000).

SECTION 3: That the City Auditor is hereby authorized to draw his warrant upon the Treasurer of the City for these funds for the purpose stated.

SECTION 4: That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety, and welfare and for further reason that the city is required to hold these monies in a dedicated fund for tracking purposes; WHEREFORE, this Ordinance shall go into full force and effect immediately upon its passage and approval by the Mayor.

#### RECLASSIFYING A FUND ADVANCE AS A FUND TRANSFER AND DECLARING AN EMERGENCY.

WHEREAS, all governments in the state of Ohio are required to adhere to Generally Accepted Accounting Principles (GAAP); and

WHEREAS, Ordinance 083-2019 approved the advance of one hundred seventy-five thousand and no/100 dollars (\$175,000.00) from the General Fund (101) to the Street Maintenance and repair Fund (201) on July 3, 2019; and

WHEREAS, if a deficit GAAP fund balance is reported and repayment is no longer expected, the advance should be converted to a transfer; and

WHEREAS, the following advance amount should be converted to a transfer in order to match GAAP fund balances with City of Whitehall cash accrual fund balances; NOW THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

SECTION 1: The advance amount of one hundred seventy-five thousand and no/100 dollars (\$175,000.00) from the General Fund (101) to the Street Maintenance and Repair Fund (201) is reclassified as a transfer.

SECTION 2: That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety and welfare of the community, and for further reason that the GAAP fund must balance by year's end; WHEREFORE, the Ordinance shall go into full force and effect immediately upon its passage and approval by the Mayor.
