OFFICIALS' REPORTS

Mayor Kim Maggard – she welcomed everyone to the meeting tonight and said it was nice to see some new faces. She said that Whitehall Parks and Recreation department won multiple awards at the State of Ohio Parks and Recreation conference. The Park Ranger Program and the program that involves the police officers patrolling the parks, both won awards. They got a first place award for the Three on Three Basketball Tournament and a second place award for the unique weekend event, which ended with the tournament. She asked everyone to congratulate Director Sorrell and the Parks and Recreation Commission on their accomplishments.

City Attorney Michael Bivens – he thanked everyone for coming this evening. His official report for the month of October: they prosecuted 328 cases in Mayor's Court; only 47 of them were of a criminal nature committed by Whitehall residents. They have four individuals that are participating in the Drug Court Program. They meet every Tuesday at the Police Station and go through the list of things that are required through Drug Court and they are seeing success.

He stated that it is election night and everyone's emotions are high. Anyone that runs for office knows that it is honorable to try to lead and to express your ideas, but one thing he hopes is that as a city, country or state we can come together civilly and agree to disagree. He hopes to come together to champion the greatest ideas of our democracy and not the ideas of pettiness. It is a pond designed as a detention basin for water and he would like to know what they intend to do with the additional storm water that will be caused by the new project. He asked if they would redesign that corner so it is beneficial to not only them, but also to the local residents and the entrance to the parkway system. It would be nice if that corner could be a continuation of the park or at least look like it by designing a water system as a bio retention basin and walking gardens.
