WHITEHALL CITY COUNCIL MEETING

MINUTES – January 2, 2024

President Potter called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, January 2, 2024.

At President Potter's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

On roll call by the clerk, the following members of council were present:

APPROVAL OF MINUTES:

Mr. Dixon moved to approve the December 19, 2023 agenda and regular meeting minutes. Ms. Heck seconded the motion. There was no discussion. On a roll call vote, Smith- Yes; Harcar- Yes; Dixon- Yes; Morrison- Abstain; Elmore – Yes; Heck- Yes; and the minutes were approved as submitted.

APPROVAL OF COMMITTEE APPOINTMENTS:

Mr. Dixon moved to accept the Committee Appointments. Mr. Morrison seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and the Committee Appointments were approved for 2024 - 2025 term.

ELECTION OF PRESIDENT PRO TEMPORE:

President Potter opened the floor to accept nominations. Once there is a nomination with a second, the individual will be asked if they accept the nomination, if accepted then there will be a vote.

Ms. Smith moved to nominate Mr. Morrison as President Pro Tem and Ms. Heck seconded the motion. Mr. Morrison accepted the nomination. On a roll call vote, Smith- Yes; Harcar- Yes; Dixon- Yes; Morrison- Abstain; Elmore – Yes; Heck- Yes; and Mr. Morrison will be the President Pro Tem for 2024 and 2025.

POLL PUBLIC:

Holly Stein, 831 Fairway Blvd, Whitehall 43213 wants to make a proposal to Council. She had talked with a couple of the Councilmembers for 2024. She would like to see a different process for which the public, who comes up for Poll Public, would not have to give their home address. The reason she is requesting this is that she had people come to her home address after a series of meetings that were held and she does attend other meetings where you just have to say your

name and you sign-in for security purposes. She has spoken with Councilperson Elmore and she feel it is an issue of safety for the community.

President Potter said he does not have an answer for her but it is a great question and they will certainly take a look at that procedure and he appreciates her thoughts on this.

OFFICIALS' REPORTS

Mayor Michael T. Bivens – he wished everyone a Happy New Year. He thinks today has been a very resplendent day to say the least. First of which was to see the beautiful smile on Clerk of Council Julie Ogg's face when she received her Master Municipal Clerks designation today. Congratulations and it is well deserved. Then coming into the Mayor's office this morning, it is important to say publically, as well as to Council and the public that this is the first day in twenty years that he has come to work without the practice of law on his mind. Practicing law for the last twenty years has been an extreme honor and privilege and has been an oath that he has given to the Supreme Court of the State of Ohio to keep client confidences. He says that to Council, in the past eight years as well as to the public he has served as the City Attorney and he has protected the confidences and privileges of Council. Brad Nicodemus will agree with him as an attorney, he is the first attorney to ascend to the Mayor's office in the history of the City of Whitehall. To that degree, there was a gray area that he was existing in for a period, where he is the attorney and he is about to become the client. There were things he could not say, things that were not ethical to be a part of and conversations that he should not have been involved in. Notwithstanding Council, everything that they engaged in during the past eight years as their City Attorney is still privileged and is still protected communication so they have no issues as it relates to that. However, this is a new day. As the Mayor, transforming into the actual now client of not only the City Attorney as well as outside counsel, there will be a noticeable shift that Councilmembers and the public will see, one of which he would like to announce that in the upcoming weeks, just stay tuned. He is going to create some working groups from the Mayor's office. One of those working groups will be wholly committed to, as he said in his acceptance speech on Sunday, about creating healthy families. This working group will be committed to healthy families as well as housing. He will not need Council appropriation for this. It will be a working group exclusively out of his office and they are going to dream big about how to make Whitehall win. With that being said, today was also a day where he was fortunate enough to be able to interview some great candidates for Administrative Assistant to the Mayor as well as Economic Development. There is another round of interviews going on tomorrow so just stay tuned. If he is given time to get his feet underneath himself, they have some great things ahead of them and he is looking forward to working with this Council so that Whitehall can continue to be able to say that opportunity is here.

City Attorney Bradley S. Nicodemus – he introduced himself as the City Attorney. It feels odd to say that because the last ten years he has been the Assistant City Attorney. He used Mayor Bivens opportunity is here as a segway, if the name is familiar and the face is not. Fifteen years ago, he walked through the doors as a law student, needing a few hours in law clinic and needing to learn a little about Mayors Court. Little did he know that fifteen years later he would be sitting up there. He came in, fell in love with the place and he never left. He actually spent five years volunteering time in Mayor's Court and picking up several prosecution gigs for then City Attorney Shannon. When he figured out that he was not going to get rid of him, Mr. Shannon hired him on as Assistant City Attorney. He is thankful for the past eight years under Mayor Bivens' office and the programs that have been started. He is looking forward to keeping them going and expanding them. Council knows that he gave some data at meetings and he intends to continue that. He loves data. Before he became an attorney, he was a computer programmer with a degree in economics. He loves data. He does not have the resident numbers as he often reported as this is the first day in office and his clerks are out. He did have some numbers he wanted to share with Council and he did want to give them to Mayor Bivens for the last meeting but was not able to. The Attorneys office has two part-time prosecutors in Franklin County Municipal Court and they alternate days. They handle misdemeanor cases down there. Those two prosecutors were scheduled for six thousand seven hundred and twelve hearings last year. If you try to do the math, with two hundred sixty working days, that is twenty-six cases per day. That is a lot. He thanked Leslie and Kylie, their downtown prosecutors because six thousand court appearances is a lot. He has worked with Council in the past just as Mayor Bivens has for the past eight years; his door is open, give him a call, send him an email, he is always happy to sit down with anyone and talk about the things that need to be talked about.

City Auditor Steve Quincel – he has no legislation before Council, however it will be coming. The office is focused on closing December 2023 and calendar year 2023. Once that work is completed, the work for 2024 will begin.

Public Safety Director Van Gregg – was not present.

Treasurer Shaquille Alexander – had no official report. Council can expect his numbers on January 16. He welcomed the new Councilmember and the returning one as well. He congratulated Michael Bivens on becoming Mayor. He wished everyone a Happy New Year.

President Potter – advised that the following reports have been filed in the Council office since the last meeting: The Treasurer's Investment Reports for November 2023, The Treasurer's Activity by Fund Report for November 2023 and The Treasurer's Fund Reconciliation Report for November 2023.
