### <u>ORDINANCE NO. 002-2024</u> DRAFT # 1

APPROVING AND MAKING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF EIGHT THOUSAND TWO HUNDRED EIGHTEEN AND 20/100 DOLLARS (\$8,218.20) FROM UNAPPROPRIATED MONIES IN POLICE DEPARTMENT GRANT FUND (212) TO THE 212.000.50050 PD GRANT FUND CADET INTERNSHIP PROGRAM EXPENSE ACCOUNT AND DECLARING AN EMERGENCY.

This original grant was fourteen thousand dollars, which the city received last year. This inadvertently was omitted from the budget list. In the financial system, there is zero dollars. The money shows on the revenue side. It needs to be on the expense side so that the city can pay the cadets. This has to go on an emergency because the cadets are owed money.

Mayor Bivens said the 2024 budget would not need amended by Council. He will bring forth fund transfers and requests for appropriations.
