WHITEHALL CITY COUNCIL MEETING MINUTES – JANUARY 16, 2018

Council President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, January 16, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

Councilman Rodriguez was sworn in for his new term as council member for Ward 1.

On roll call by the clerk, the following members of council were present:

EXCUSE ABSENT MEMBERS

Mr. Bailey moved to excuse the absent members and Mr. Rodriguez seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and Mr. Morrison was excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the December 19, 2017 and January 2, 2018 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and the Minutes were approved as submitted.

POLL PUBLIC

There were no further comments for poll public.

STANDING COMMITTEE REPORTS

Administration and Financial Management – Chairperson Bailey reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Community and Elder Advocacy – Chairperson Elmore reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Community Standards and Enforcement – Chairperson Rodriguez reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Economic Development – President Graham reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Infrastructure, Maintenance and Services – Chairperson Heck reported that they met last Tuesday and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Public Safety – Chairperson Conison reported they met last week and their minutes are on file. She said Chief Crispen gave her some updates from the police department. They had a meeting with the Chamber of Commerce and have established an anti-theft program for businesses. He reported that in 2017 burglaries and robberies were at a 20 year low and violent crime was the lowest since 2011. Officer Eric Runyon was sworn in last week and the next town hall meeting will be February 15. They will meet next week, sometime after 6:30 p.m.

Parks and Recreation – Councilman Kantor reported that they met last week and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – she asked for favorable consideration for Ordinance Nos. 003-2018, 004-2018 and 005-2018. She reported that HB 371 was voted out of the house today. HB 371 is the bill that will stop any property tax accrual or increase on residential properties that are to be developed. Every public sector is against this because it takes tax dollars away from cities and school districts. As a municipality it takes away local control which seems to be the theme in the state house. Without any permission or guidance they can put freezes on increases on land.

She explained that the county commissioners are very concerned about poverty rates in Franklin County. The county has grown in economic development, but poverty rates are not going down. As a member of the reginal policy round table she is asking to focus on food and security for the next policy agenda that will come up in 2019/2020. The city has promised to put in \$10,000 for the Broad Street corridor. This is a county wide project and it will help study transportation along with assisting in choosing businesses that meet the need for the residents. We want to have stores that are accessible to our residents and that are not too expensive.

City Attorney Michael Bivens – he complimented the mayor on her progressive stand on the city. He reiterated that the county commissioners are very concerned about poverty rates. Mayor Maggard has been so concerned about it; she sought out and received \$736,000 that is going towards raising the quality of life for Whitehall residents.

He is going to a conference in Tennessee hosted by the National Association of Counties. He felt this would be a good conference because we have been given the first and only grant to facilitate a drug docket in Mayor's Court. There are many counties looking for solutions for the opioid epidemic and he is going to share what Whitehall is working on. There are two to five million people in county jails for drug and alcohol additions. Whitehall should be commended for looking for a strategic approach to handle this problem.

He reported that his office is actively involved in nuisance abatement with respect to drug and alcohol problems as well as violence in the homes. They have successfully litigated five cases and we were able to abatement the nuisance in private property. He asked council to let the residents know to call his office if they have a problem with a neighbor that is related to drug, alcohol or violence. If it meets the nuisance abatement criteria they will file charges, even if that person is the owner of the home. That is one of the tools we are using to actively engage and make sure our neighborhoods are safe.

The Legal Rams have been moved to Licking County Municipal Court on January 26 to compete in the Ohio Mock Trial competition, first trial is 9:30 a.m. and second trial is 1:30 p.m.

City Auditor Dan Miller – he reported that he went to a meeting on TANF (Temporary Assistance to Needy Families) program. They gave an detailed introduction to the program and showed them how to administer the grant. He asked for favorable consideration for Ordinance No. 004-2018.

Director of Public Service and Development Zach Woodruff – not present

Treasurer Steve Quincel – he had no official report.

Mayor Maggard said they will be honoring Council woman JoAnna Heck, School Resource Officer Mark Showater, Parks and Rec. Commission member Katie Quincel and Lenore Miller from the Senior Center at the Education Foundation Dinner.
