WHITEHALL CITY COUNCIL MEETING MINUTES – JANUARY 17, 2017

Council President Jim Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, January 17, 2017.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

On roll call by the clerk, the following members of council were present:

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the January 3, 2017 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and the Minutes were approved as submitted.

Mayor Maggard asked Director Chuck Underwood to come forward. She said that Director Underwood has been a good friend and mentor. She presented him with a Proclamation and declared Wednesday, January 18 as Charles "Chuck" Underwood Day. She concluded by saying that Director Underwood has exemplified what pride is and has always been available to help her and others. Director Underwood said he appreciates everything the city has done for him and he will miss the people. He wished everyone the best of luck in the future.

POLL PUBLIC

Michael Shannon, 5166 Etna Rd. Whitehall, Ohio. Mr. Shannon said he would be remiss if he didn't come to express his sincere gratitude to Director Underwood. He said that for the 16 years he served for the City of Whitehall Director Underwood was a pillar, particularly when he was City Attorney. He said he would occasionally stop by and ask a question that was like a bar exam question. He was sure that he knew the answer, but he was testing him. He stated that Director Underwood also served our country with several perilous flights during the Persian Gulf War. He reiterated that Director Underwood is an exemplary public official, exemplary citizen and exemplary neighbor. He said he can't think of any one he would rather have as his neighbor, his City Attorney, his Ward 4 council person or as his Safety Director. He said he did not yell or scream a lot and had an amazing ability not to get excited when everyone else was. He concluded by saying he learned and awful lot from Director Underwood and wanted to share these sentiments with his former elected officials and colleagues.

STANDING COMMITTEE REPORTS

Administration and Financial Management – Chairperson Bailey reported that they met last Tuesday and discussed several pieces of legislation that are on the agenda tonight. Their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Community Engagement – Chairperson Conison reported that they met last week and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Community Standards and Enforcement – Chairperson Rodriguez said that they met last week and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Economic Development – Chairperson Morrison said that they met last week and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Infrastructure, Maintenance and Services – Chairperson Gregg said that he was not here last week, but the committee met and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Public Safety – Chairperson Stahley said they met last week and their minutes are on file. He thanked Director Underwood for all his service to the city under all of the different aspects he served. The Safety Committee will meet next week, sometime after 6:30 p.m.

Parks and Recreation – Chairperson Kantor said that they met last week and their minutes are on file. He announced that there is a new Parks and Recreation Director named Shannon Sorrell.

OFFICIALS' REPORTS

Mayor Kim Maggard – asked for favorable consideration of Ordinance Nos. 002-2017, 003-2017, 006-2017, 007-2017 and 008-2017. She said they have been interviewing for a Community Affairs Manager and they hope to make an announcement by Friday.

City Attorney Michael Bivens – updated council on the end of year numbers. He said that out of the 2030 criminal cases last year, 257 were Whitehall residents, which is 12%. He explained that tomorrow is the first of several seminars with the Whitehall Police Department. This one will cover three main topics; dog sniff evidence, domestic violence evidence and collection of digital evidence. He said it is exciting to educate our officers regarding evidence so the conviction sticks. He said that this Friday the Whitehall Yearling High School Mock Court Team will be doing their first Mock Team Competition. He thanked former City Attorney Michael Shannon for coming this evening and for always being such a gracious mentor to him. He said he is a shining face and friend. Lastly, he said that Director Underwood has always presented himself as a type of attorney that he aspires to be. He said that he classified Director Underwood as a renaissance man; there is more to him than meets the eye. He can fly planes, litigate cases, and be a father, a friend and a good neighbor. He is pleased to have Director Underwood be a representative that always had the best interest of Whitehall in mind.

City Auditor Dan Miller – had no official report. He stated that if anyone ever wants to view the auditor's reports they can go to the auditor's webpage, under reports. He post them each month.

Director of Service and Development Zach Woodruff – said beginning tomorrow construction crews will begin work on replacing the water line on Elaine Rd., south of Main St. He hopes that work will be done by the end of July. He said it has been an honor working with Director Underwood in his different capacities.

Treasurer Steve Quincel – had no official report. He said Director Underwood is a good friend and neighbor and an inspiration.
