WHITEHALL CITY COUNCIL MEETING

MINUTES – February 5, 2019

President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, February 5, 2019.

At President Graham's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

EXCUSE ABSENT MEMBERS

Ms. Elmore moved to excuse the absent member and Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and Ms. Conison was excused.

Mr. Kantor moved to approve the Minutes of the January 15, 2019, agenda and regular meeting minutes. Mr. Morrison seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and the minutes were approved as submitted.

POLL PUBLIC

Todd Wilson, 900 Fairway Boulevard. He has been a resident of Whitehall for 23 years. He explained that he was at Wal-Mart on Superbowl Sunday and when he came out there were police officers and pedestrians surrounded his car. He noticed a police officer was closing his car door. The officer explained to him that they had a report of a drunk driver in the area matching his vehicle. He was here tonight to let council know what happened to him so it does not happen to anyone else in the future.
