WHITEHALL CITY COUNCIL MEETING MINUTES – FEBRUARY 20, 2018

Council President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, February 20, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

EXCUSE ABSENT MEMBERS

Mr. Bailey moved to excuse the absent members and Mr. Rodriguez seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and Mr. Kantor was excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the February 6, 2018 agenda and regular meetings. Mr. Morrison seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and the Minutes were approved as submitted.

POLL PUBLIC

There were no further comments for poll public.

STANDING COMMITTEE REPORTS

Administration and Financial Management – Chairperson Bailey reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Community and Elder Advocacy – Chairperson Elmore reported that they met last Tuesday and their minutes are on file. They discussed Ordinance 015-2018. They will meet again next week, sometime after 6:30 p.m.

Community Standards and Enforcement – Chairperson Rodriguez reported that they met last Tuesday and their minutes are on file. They discussed Ordinance Nos. 021-2018, 022-2018, 013-2018 and 014-2018. They will meet again next week, sometime after 6:30 p.m.

Economic Development – Chairperson Morrison reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Infrastructure, Maintenance and Services – Chairperson Heck reported that they met last Tuesday and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Public Safety – President Graham reported they met last week and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Parks and Recreation – President Graham reported that they met last week and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – she had no official report.

City Attorney Michael Bivens – he reported they have 30 individuals that are currently in the diversion program through Mayors Court. They graduate in the next three weeks and there are 40 more individuals that will start the program. Tomorrow at 1:00 p.m., he was invited to participate on a panel at the High School to discuss youth violence.

He invited everyone to the Youth Justice Circle presentation on February 26 at 6:00 p.m. in City Hall. The Justice Circles were created in collaboration with his office, Judge Gill and the Juvenile Probation Department to be a diversion effort for juveniles. It invites the community to be a part of the sentencing consideration for juvenile offenders. The 43213 zip code has the highest rate of youth detainment in central Ohio. It is not necessary to be a Whitehall resident to participate; you just need to be a person that wants to help prevent youth crime and violence.

The City Attorney's Office and Franklin County Restore to Justice Program are starting something different. They are looking at the opioid epidemic as it relates to violence and crime as a public health epidemic. It is everyone's problem and we need to approach it with an idea that these things can be tracked and monitored and we could help with the symptoms and diagnose. The hopes are that we can start solving this problem and making a difference for the residents and visitors of the city. He stated that opportunity is in Whitehall, but some of those opportunities are yet to be uncovered.

City Auditor Dan Miller – he asked for favorable consideration on Ordinance Nos. 006-2018, 007-2017, 008-2018, 009-2018, 018-2018, 019-2018, 020-2018 and Resolution Nos. 012-2018 and 013-2018.

Director of Public Service and Development Zach Woodruff – he thanked council for being supportive over the winter season. He reported in 2016 and 2017 combined they had used 2600 tons of salt. This winter alone they have used 2400 tons of salt and have had to order more.

Treasurer Steve Quincel – he reported that it has been six months since the city has switched their banking to Heartland Bank. The problem they had with Key Bank was the fees were eating up any interest they were getting from the other investments. The last six months at Key Bank the average interest earned was \$5800 a month and the fees were \$1143 a month, so the net was \$4657. The first six months at Heartland bank the average interest earned was \$11,825 and the fees were \$716 a month, so the net total was \$11,110 a month. Today he made the first deposit in the new Whitehall branch. The Grand Opening for that branch is March 20 at 4:30 p.m. Lastly, he was excited to report that he became a Grandpa again.

Ms. Elmore recognized February as Black History Month and gave a brief history of what that means and the contributions African Americans have made in Ohio. In 2013 Whitehall residents elected their first African American School Board member, Joy Bivens. In 2015 Whitehall residents elected their first African American City Attorney, Michael T. Bivens and in 2017 the Whitehall residents elected their first African American Council member, Lori J. Elmore. Whitehall is changing the culture and becoming a more inclusive community and we should be proud of that. She is grateful and thankful to the citizens of Whitehall for recognizing that everyone has more in common than they do different.

Ms. Conison said at her job she is in charge of the diversity committee and they have been celebrating Black History Month. She shared a story from the first black County Commissioner, Kevin Boyce. He remembers playing basketball in High School and coming home and telling his grandmother that he wants a new pair of cool tennis shoes like the other kids are wearing. His grandmother took him to the local grocery store and told the manager that her grandson needs a job so he can buy himself some tennis shoes. She said to him that nothing in life is free, everything is earned and to be proud of being a black American and she stressed American. She taught him a lesson that he will never forget. Ms. Conison said she loved that story and she is going to tell it where ever she goes. She thanked everyone for coming and hopes to see everyone next time.

President Graham thanked everyone for coming. He said that Frederick Douglas in 1800's was a slave and then became one of the most influential and respected African Americans of his time. He said it was not fair for the white man to compete against a group of people that worked for little or no wages. The Carpenters Union was just getting started and was active in political issues and they got involved in the slavery issue because they didn't think it was right. It is a shame that we don't know some of the things that have happened in the past to help form our county today.

Having nothing further, Mr. Bailey moved to adjourn and Mr. Rodriguez seconded the motion. On a roll call vote, all present members responded in the affirmative and the meeting adjourned at 7:44 p.m.
