Mayor Bivens gave a reminder for old Councilmembers and new Councilmembers as well, last year there were a number of presentations regard the infrastructure but particularly the underground lines and the need citywide to do something to replace and abate some of the problems. There was a plan put in place to get these lines fixed and replaced. Obviously, not coming from the general fund or the capital dollars because the expense was so high, the Auditor and the previous administration looked into doing an infrastructure loan on that. They have not talked about this in a very long time. What he proposes, and he has spoken to the Auditor as well as his staff and he wants to come to Council to do a full presentation of what the infrastructure loan would be, what projects it would encumber and what would be the timeline on that. Before he intends to sign any loan documents, obviously this needs to start from scratch so that Council is fully aware and can give it the full green light with their understanding and knowledge and they let the public know whether or not they want the city to go forward in fixing a portion of underground lines that are in desperate need of repair. He wanted to fill Council in, as this is a precursor to a more robust conversation.

PUBLIC SAFETY

Chairperson Morrison opened at 7:49 p.m. and said there are no drafts or pending legislation on the agenda.

Mayor Bivens said next week Chief Crispen will come in and do a presentation that has not been named yet, but essentially it is a Whitehall Public Safety Advisory Group and the plan is to open up a collective group to address safety concerns and implement active measures that enhance public safety. It is similar to a citizen advisory group, but it would include Mayor, Fire Chief, Police Chief, Service Director, HR Director, Councilmember and three to five community leaders that would be on this advisory group. This would be a group that would address

public safety concerns to enhance and give directive to assist the Public Safety Director and assist the public with those concerns. Chief Crispen will be there to talk about that and he wanted to prepare Council for that.
