WHITEHALL CITY COUNCIL MEETING MINUTES – MARCH 7, 2017

Council President Pro Tempore Bailey called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, March 7, 2017.

At Council President Pro Tempore Bailey's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

On roll call by the clerk, the following members of council were present:

EXCUSE ABSENT MEMBERS

Mr. Rodriguez moved to excuse the absent members and Mr. Stahley seconded the motion. There was no discussion. On a roll call vote, the six present members responded in the affirmative and President Graham and Mr. Kantor were excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the February 21, 2017 agenda and regular meetings. Mr. Morrison seconded the motion. There was no discussion. On a roll call vote, the six present members responded in the affirmative and the Minutes were approved as submitted.

SPECIAL PRESENTATION

Attorney Michael Bivens provided a power point presentation explaining on how Mayor'ss Court works and the new diversion program which he is calling the Strategic Community Initiative. An electronic copy of the presentation was placed in council's power point folder. He introduced Derrick Owens, Larry Thomas, and Kevin Miller with the Columbus Urban League. They explained some of the goals their program strives to achieve in Mayor'ss Court. Their goals are to give people the resources needed to ultimately help them rehabilitate. Mr. Owens said they call themselves career coaches. Attorney Bivens introduced Brad Nicodemus, Whitehall Assistant City Attorney and Kylie Keitch, Whitehall Prosecutor. Ms. Keitch said how nice it is as a prosecutor to be able to send an individual who wants to change their life to someone in the next room who can help them do that. Mr. Nicodemous said he was skeptical of the program at the beginning, but now he sees it work. He says the difference is the defendants want to help themselves and the Urban League is giving them a chance to do that. He introduced Ms. Pittman who shared her story of having a license suspension that spiraled out of control which caused her to lose her job and has prevented her from getting another one. She said the Urban League helped her get the resources she needed to rectify the situation and get her back on her feet. Mr. Nicodemus was excited to let Ms. Pittman know that everything was rectified and her case is dismissed. Lastly, Attorney Bivens thanked everyone involved to make this program work.

SPECIAL PRESENTATION

Joe Ryan, Economic Development Specialist presented a power point presentation updating council on the Whitehall Chamber of Commerce. An electronic copy of the presentation was placed in council's power point folder. He introduced the President, Cindy Page with Wallick Communities and Vice President Debbie Moore with Ernie's Automotive.

Parks and Recreation – Council President Pro Tempore Bailey said that Chairperson Kantor was not able to be here this evening, but the committee did meet last week and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – thanked everyone for coming out this evening. She thanked the Urban League for helping with our residents. She thanked Attorney Bivens for getting this program up and running. She thinks it is going to be good for the City of Whitehall and the communities that surround the city. She said "Go Chamber" for rocking it and she just sent a check in to join. She wants to be a partner with them and would like to help them in any way. She asked for favorable consideration for Ord. Nos. 016-2017, 017-2017 and Resolution 014-2017. She explained that Resolution 014-2017 is opposing House Bill 49 which is the collection by the state of our business income tax. The state wants to charge us 1% for all of our collections net profits. She said we do a good job collecting these taxes and we still want to provide services to our businesses.

City Attorney Michael Bivens – reported there were 133 cases in Mayor's Court for the month of February, only 30 were Whitehall residents and 25 of those were criminal. He asked for favorable consideration for Resolution 014-2017. He stated he is excited to hear the upcoming State of the Community address because this is the city of opportunity.

City Auditor Dan Miller – had no official report. He asked for favorable consideration on Resolution 014-2017. He said his staff does a great job collecting these taxes and they do not need the help from the state. He asked for favorable consideration for Ordinance No. 022-2017 and Resolution Nos. 011-2017, 012-2017, and 013-2017.

Director of Service and Development Zach Woodruff – had no official report.

Director of Public Safety Mark Newcomb – reported on March 2 the Police Department began carrying Narcan to revive individuals who have overdosed. The city received the Narcan kits free of charge from the Franklin County Board of Health. He thanked the fire department EMS Coordinator, Mike Burns on conducting the training for the entire police department. He said that April 4 the Fire Department will participate in a county wide mass casualty drill.

Treasurer Steve Quincel – had no official report, but asked for support of Resolution 014-2017.

Council President Pro Tempore Bailey asked for a motion to approve raises for council staff. Mr. Rodriguez moved to give a 2% raise to council employees, retroactive to January 1, 2017. Mr. Morrison seconded the motion. On roll call vote, the six present members all voted in the affirmative and the motion carried.

POLL PUBLIC

Lori Elmore, 645 Fairway Blvd. Whitehall, Ohio. She thanked council for the opportunity. She wanted to speak on behalf of all the great things Whitehall is doing, specifically to the mayor for bringing up House Bill 49. She feels that this could be detrimental to the City of Whitehall and the progress that has been made. She asked the citizens of Whitehall to contact their house and senate representatives and the people of the committee to let them know that they oppose this legislation. She feels that is a responsibility of citizens of Whitehall. She reiterated how important

it is to call Kevin Beacon and Heather Bishoff and the other people that are on the committee regarding the finances of the budget.

Director Woodruff introduced Kaitlin King, who is our new Community Affairs Manager. He stated that she has a lot on her plate with the State of the Community, Food Truck Festival, Resident Guide, 4th of July, etc. He said she will be reaching out to everyone shortly, but he felt it was important to formally introduce her.

COMMUNITY DATE BOARD

Events are listed on the City's Website. Director Woodruff said the State of the Community event, which is a joint event with the city, chambers and the schools will be March 22 at 6:30 at the Kae Ave. Elementary School. The Mad Greek will be providing refreshments at 5:30 p.m. He said they are excited about being able to recap 2016 and share what the community is doing for 2017.

Ms. Conison announced that on April 4 they will be stuffing Easter Eggs at Whitehall Yearling High School and April 8 is the Easter Egg Hunt at John Bishop Park at 10:00 a.m.

Ms. Conison thanked everyone for staying to the end of our council meeting. She thanked the Urban League and Ms. Pittman for sharing her story and for the Whitehall Chamber of Commerce.

Mr. Stahley thanked Attorney Bivens and the Urban League. He commended Ms. Pittman for the courage she showed by sharing her story. He said that is an example of what is working in our city. He thanked Mr. Ryan and the Whitehall Chamber. Lastly, he thanked Mr. Newcomb for telling the citizens about the Narcan. He shared that when he went on a police ride along he got to know how Narcan is saving individual lives.

Mr. Morrison thanked everyone for coming and complimented the Urban League and Chambers on what a great job everyone is doing.

Mr. Rodriguez thanked the Urban League and Attorney Bivens for the presentation. He welcomed Ms. King on board. He stated that the council clerks raises are well deserved and their wealth of knowledge is invaluable. He thanked Ms. Elmore for talking about Resolution 014-2017. He said it is something we have to go after as a community. He explained that we can also call other elected officials in other communities. We need to have everyone understand our point. He said they keep talking about home rule, but they keep taking it away and we need to fight for it.

Mr. Gregg thanked everyone for coming. He thanked Attorney Bivens and the Urban League and said it is nice to see results. He thanked the Chamber and welcomed Ms. King on board.

Council President Pro Tempore Bailey said how proud he is of all the work that everyone is doing. He said that he remembers a saying that reads, "that if a man is hungry you're not just giving him a fish you're teaching him how to fish." He said that is the path that we need to take and he is proud of it. He stated there is new life in Whitehall and everyone is making a difference.
