City Attorney Bivens replied by Charter you have the right to approve your own rules and it does not need to go to a formal vote with a motion and a second.

Council President Pro-Tem Bailey asked for a show of hands if you were okay with the current Rules of Procedure and putting them in place and we can revisit any ideas that Chairperson Elmore may have later.

Council President Pro-Tem Bailey asked the Clerk to let the record show that all Council members were in agreement and that he knew Chairperson Kantor was okay with the current rules.

#### **SPECIAL PRESENTATION:**

M.O.R.P.C. to present the 2020-2050 Metropolitan Transportation Plan.

Thea Walsh, Director, Transportation & Infrastructure Development gave an overview of the MTP which identifies regional transportation strategies and projects, 20 plus years of long range goals, fiscally constrained and the formal document submitted to ODOT and USDOT every 4 years. She outlined the regional goals as reducing energy consumption and promote alternative fuel resources to increase affordability, protect natural resources and mitigate infrastructure vulnerabilities to maintain a healthy ecosystem and community, position central Ohio to attract and retain economic opportunity to prosper as a region and compete globally, create sustainable neighborhoods to improve residents quality of life, increase regional collaboration and employ innovative transportation solutions to maximize the return on public expenditures and to use public investments to benefit the health, safety, and welfare of the people.

At this time, Thea Walsh answered questions from Council members.

# ORDINANCE NO. 014-2020 - Draft # 3

APPROVING AND MAKING A SUPPLEMENTAL APPROPRIATION OF SEVEN THOUSAND EIGHT HUNDRED SIXTY-FIVE AND 88/100 DOLLARS (\$7,865.88) FROM THE TAX INCREMENT FINANCING FUND (279) TO VARIOUS EXPENSE ACCOUNTS IN THE 279 FUND AND AUTHORIZING THE DISTRIBUTION OF THE PORTION OF THE FEE PAYMENTS ATTRIBUTED TO EACH TIF IN THE TOTAL AMOUNT OF SEVEN THOUSAND EIGHT HUNDRED SIXTY-FIVE AND 88/100 DOLLARS (\$7,865.88) TO THE TIF FEES ACCOUNT (279.000.59600) AND DECLARING AN EMERGENCY.

Auditor Miller said the reason for so many pieces of legislation for this one thing is when he did the budget at the end of the year for the next year he knows how much to deduct out of the TIF. He can put those figures into the budget but he has no idea what the TIF fee's and the revenue sharing are going to be. He keeps those open and he has to appropriate, remember Draft 2 appropriates the money for the TIF fees. He did not think Draft 2 was needed and that it was redundant. He is already making a supplemental appropriation with Draft 3 and he is making an appropriation in Draft 1. He withdrew Draft 2 from the agenda.

Auditor Miller said he will say this about the delinquent taxes. He has requested to have all the delinquent taxes abated and refunded to the City including all the interest and penalties. Those properties were eligible for what is known as non-productive land. As soon as we acquired them they should have been tax exempt from the beginning. He did receive last year's county taxes abated and now he is working on these years. They sent the tax bills late and to the wrong address. That wrong address then forwarded them to the City. That is a big chunk of money if he can get it back.
