# WHITEHALL CITY COUNCIL MEETING MINUTES – MARCH 20, 2018

,

Council President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, March 20, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

## **APPROVAL OF MINUTES**

Ms. Conison moved to approve the Minutes of the March 6, 2018 agenda and regular meetings. Mr. Rodriguez seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and the Minutes were approved as submitted.

#### ADOPTION OF COUNCIL RULES OF PROCEDURE 2017-2018

Ms. Heck moved to adopt the Council Rules of Procedure for the 2018-2019 Term. Ms. Elmore seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and the rules were adopted

#### POLL PUBLIC

Gerald Dixon, 3877 Doney St. He explained that he sent a letter to council regarding his concerns on amending in the city code, section 745, Vendors and Solicitors. He is upset that no one has discussed his letter with him and he is requesting that they reply during poll council this evening.

Chris Miller, 295 Laurel Lane, Pataskala, Ohio. He is here to state his opposition against the legislation for an attempted takeover of the Woodcliff Condominiums. He is a recent owner of a condominium and has done a lot of work to his property. It has come to his attention that there is ongoing litigation that he and many of the other recent purchasers were not aware of. When the title work searches were done, the only issue that came up was an \$18,000 lien against the common property, which is an IRS lien. At the hearing on Tuesday, the city's attorney said that the newer owners should have known about the issues but they did not know. The issues that the city is using to try to take over the property are not correct. If sewer and water hookups and the curb cuts are not up to code today, then these properties should be grandfathered in. He is speaking as a citizen that has owned properties for many years, not a lawyer or code enforcement person. He stated that the city is trying to take the properties only so they can develop them the way Whitehall wants it

developed. He doesn't appreciate his property being taken from him forcibly at a much lower price than it is worth.

Boltob LLC, 140 Woodcliff Dr. He said he owns multiple Woodcliff Condominiums and that he was given no warning about the issues before purchasing them. He knows the city may have the right to take over the properties, but he thinks they should acquire the property at fair share. He thinks it is unfair and is asking the city to look in to it more objectively. He knows that some of the condominiums are out of code and he is requesting to give them time to correct the problems and to look at them on a case to case basis. He is asking the city to be fair and to not make them suffer for the mistakes that others had made.

John Freeman, 1178 Fountain Lane, Apt B. He purchased two duplexes in Woodcliff; he has restored them and has tenants in both units. He felt it was a good opportunity to have a solid income stream. Unfortunately, many things were not divulged before closing by the prior owner, but he understands that is a separate issue and should be addressed with his lawyer. He was interested in Woodcliff because it represents a kind of unit that is disappearing. It also represents the kind of community that he wants to live in with middle and lower income people that are trying to make ends meet. The community is going to be displaced and he doesn't know where the families are going to go. He speaks highly of Whitehall and believes the future of Whitehall is very bright. However, he doesn't understand where the city wants to end up and thinks they are making a big mistake.

City Attorney Michael Bivens – he reported they had an opioid court meeting today. He hopes to launch that project in the next 60 to 90 days. Because this project is funded with money from the federal government, they anticipate Senator Portland coming to the next meeting and checking on the progress. On May 17, the Legal Rams will be doing a mock trial at city hall. He has invited everyone to come out and be a part of the jury.

When the citizens of Whitehall ask for answers, they should get them and not be left hanging.

President Graham said that it is in litigation and they have no comment at this time.

Attorney Bivens advised her to check with the Woodcliff Condominium Association and Mark Froelich, who is the receiver for the property.
