# **MINUTES** – March 20, 2024

President Potter called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Wednesday, March 20, 2024.

At President Potter's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

On roll call by the clerk, the following members of the council were present:

Ms. Elmore moved to excuse the absent member and Mr. Dixon seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and Chairperson Morrison was excused.

Mr. Brown moved to approve the March 5, 2024 Agenda and Regular Meeting Minutes and the March 12, 2024 Agenda and Committee Meeting Minutes. Ms. Harcar seconded the motion. There was no discussion. All members responded in the affirmative on a roll call vote, and the minutes were approved as submitted.

### SPECIAL PRESENTATION:

Monnette Wike, Communications Manager shared with the Council and the Administration that Council has their own Facebook page as of today. During the set-up, she linked it to Instagram, the city website, and YouTube. She described the analytics for engagement. She addressed the concerns that the Council had at the last discussion. The program she would like the city to purchase is Stream Yard. The cost to the city will be two hundred thirty-nine dollars. Ms. Wike answered questions from the Council at this time.

#### OFFICIALS' REPORTS

Mayor Michael T. Bivens – he is coming up on one hundred days in office. On April 10, 2024, the State of the City will be held at the YMCA beginning at 5:30 pm. He expects it to be a fantastic event and he wanted to personally invite members of the public and the Council to attend. It is still National Women's History Month and he had a couple of history facts. Yesterday he went to LifeCare Alliance. Catherine Nelson Black, who was the wife of Sam Black who was the Mayor of the City of Columbus, founded it in 1898. While he and his staff attended, they prepared meals for people. Franklin County just had the opportunity to do something historic. Franklin County has been around since 1803 and yesterday through the primary election; Franklin County has the opportunity to elect its first black female county prosecutor. In two hundred twenty years, the voters in Franklin County will get the choice to vote for the first black female county prosecutor. This Friday at noon, he will be visiting for the very first Coffee and Conversation with a female-owned business, Racha Tea at 561 South Hamilton Road. Everyone is welcome to attend. The agenda is going to be very organic, there will be talk, and he wants to hear citizens' concerns and he wants to develop relationships. He is all about developing and building relationships. He congratulated Casey Thomas on her engagement.

City Attorney Bradley S. Nicodemus – next week at committee, he hopes to have more information for the Council about the tobacco retail license lawsuit. The laws will be enacted on April 23, 2024. Franklin County municipalities, Whitehall included, have TRL ordinances to help prevent tobacco and flavored tobacco from getting into kids' hands. The legislation will be to suspend the TRL ordinance should that law take effect and one of the things they will be looking at with other municipalities is joining a lawsuit against the state. What they believe the General Assembly has done is invaded our home rule authority to regulate and monitor the health and safety of the citizens.

City Auditor Steve Quincel – Ms. Wike came to his office a few days ago and shot a video that has been posted to Facebook regarding the change in the hours for the Auditors and Tax Department. A good sign regarding income taxes is that revenue for last month is more than was taken in at this time last year. Unfortunately, the tax refunds are also up for the same period. He asked for favorable consideration on Ordinance 015-2024 and Resolution 008-2024.

Director of Public Service Casey Thomas – Broad Street construction is continuing and the traffic is slow and go. Please be patient and considerate. This project will be a great reconstruction for Broad Street and the city. Councilperson Dixon brought to her the research on the zipper merge. She said it would be good for the others to research it as well. Use Main Street and Fifth Avenue as your alternate routes.

Public Safety Director Van Gregg – was not present.

Treasurer Shaquille Alexander – had no official report. He echoed Auditor Quincel's remarks.

President Potter – advised that the following reports have been filed in the Council office since the last meeting: the Auditor's Bank Report for February 2024, the Auditor's Statement of Cash Position Report for February 2024, and the Auditor's Revenue Report for February 2024.

#### POLL PUBLIC:

Merle Robinson, Whitehall, OH spoke on the Stream Yard project. He has used this tool since 2020. He runs several of his conferences with it. The quality is very good. It can handle ten-plus users and they are now experimenting with transcripts, so in the future, these things could be used. He encourages support for this project, as it will provide better information for the citizens.
