WHITEHALL CITY COUNCIL MEETING MINUTES – MARCH 21, 2017

Council President Jim Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, March 21, 2017.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

Mr. Kantor moved to excuse the absent member and Ms. Conison seconded the motion. There was no discussion. On a roll call vote, the five present members responded in the affirmative and Mr. Bailey and Mr. Gregg were excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the March 7, 2017 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, the five present members responded in the affirmative and the Minutes were approved as submitted.

OFFICIALS' REPORTS

Mayor Kim Maggard – asked for favorable consideration for Ord. Nos. 025-2017, 026-2017, 027-2017 and Resolution 015-2017.

City Attorney Michael Bivens – reported that the City Attorney's office has made a personnel change and the new Domestic Violence Victim Advocate is Lorena Lacey. He said he is confident that she will advance the mission of the City Attorney's office with respect to Victim advocacy. He explained that this involves empowering victims and helping them break the cycle. It also includes letting everyone in the City of Whitehall know that Domestic Violence Awareness is not just the month of October. In the future there will be information sent out to our citizens with respect to victim advocacy and Domestic Violence awareness. It is not just getting someone down to court. The goal is to get more cooperation and to inform people that the City Attorney's office will zealously prosecute anyone that is charged with Domestic Violence in the City. He asked for favorable consideration for Resolution 015-2017.

City Auditor Dan Miller – had no official report.

Director of Public Service and Development Zach Woodruff - was not present.

Director of Public Safety Mark Newcomb – reported that there are some good things happening in public safety that will affect our citizens in a positive manner. The Fire Department is starting a Community Paramedic Pilot Program on April 10. Randy Jones has been selected to fill this new role. Both Randy and the Fire Department staff have been working hard to get this program off the ground and make it a success. He said later this week the police department will take possession of the first of our two newly acquired patrol K-9's. The dog will start the training process with its handler and should be ready for street duty this summer. The two handlers are Shane Drake and Jesse Hackney. Lastly he said that the Whitehall Shell station has beenwashing the fleet for the Police Department for many years and that has really helped the city.

Treasurer Steve Quincel – had no official report.

ORDINANCE NO. 014 -2017 was read by title only by President Graham:

"AMENDING SECTION 143.15 OF THE CODIFIED ORDINANCES TITLED "EMERGENCY MEDICAL SERVICE BILLING" AND DECLARING AN EMERGENCY."

ORDINANCE NO. 015-2017 was read by title only by President Graham:

"MAKING AND APPROVING A FUND TRANSFER IN THE AMOUNT OF ONE HUNDRED TWELVE THOUSAND TWO HUNDRED FIFTY AND NO/100 DOLLARS (\$112,250.00) FROM UNAPPROPRIATED MONIES IN THE GENERAL FUND (101) TO THE CAPITAL IMPROVEMENT FUND (311) AND DECLARING AN EMERGENCY."

AS THE BARGAINING REPRESENTATIVE FOR ALL REGULAR FULL-TIME POLICE RADIO DISPATCHERS FOR A PERIOD OF THREE YEARS FROM JANUARY 1, 2017 THROUGH DECEMBER 31, 2019 AND DECLARING AN EMERGENCY."
