WHITEHALL CITY COUNCIL MEETING MINUTES – APRIL 4, 2017

Council President Jim Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, April 4, 2017.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

EXCUSE ABSENT MEMBERS

Mr. Kantor moved to excuse the absent members and Mr. Gregg seconded the motion. There was no discussion. On a roll call vote, the five present members responded in the affirmative and Mr. Bailey and Mr. Rodriguez was excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the March 21, 2017 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, the five present members responded in the affirmative and the Minutes were approved as submitted.

SPECIAL PRESENTATION

President Graham asked Community Affairs Coordinator Kaitlin King to introduce the special presentation. Ms. King introduced Angela Raveer, President of the Columbus and Whitehall Kiwanis Club. Ms. Raveer explained that the Kiwanis Club has been working over the last few years to raise money to help individuals and schools in the community. Recently they have been working with area pizza parlors to raise funds for a particular project. She asked Tracy, Dave and Kimmy Hatfield to come forward along with her husband Charles. Charles presented Kimmy on behalf of the Kiwanis Club a tricycle for children with disabilities, which is called an Amtryke. He explained that this is something that Kimmy has been wanting for years. Ms. Hatfied thanked the Kiwanis Club and said that Kimmy has been waiting to ride a bike for a long time and she will get good use of it. Ms. Raveer introduced Dave Ritter from the TASK program. He explained that the TASK program is an organization that gives individuals with special needs the freedom to do the things that everyone likes to do. He said seeing the excitement in Kimmy's face is why he volunteers. Lastly, Ms. Raveer thanked council for allowing them to give this special presentation tonight.

OFFICIALS' REPORTS

Mayor Kim Maggard – had no official report. She thanked the Kiwanis Club for the joy they brought Kimmy. She gives them kudos for raising money for a whole year for this project. She congratulated C. J. Prater and Stephanie Ellis and wished them luck on their college journey. She said everyone in Whitehall is very proud of them. She said they are also very proud of the Bowling teams. She thanked coaches Netotian and Biller for their mentoring and coaching. She said Whitehall is on the roll and she thanked the coaches for everything they do and the parents for everything they do.

City Attorney Michael Bivens – reported there were 329 cases in Mayor's Court for the month of March, only 90 were Whitehall residents. There were only 34 criminal cases that were Whitehall residents. He congratulated the Police Dept. for the shoplifting blitz that contributed to high numbers for March. He said historically March trends are a little higher. Last year we processed 255 cases in the month of March. They went from 108 cases in February to 329 in March. This shows that if you are going to commit a crime in Whitehall you will defiantly be prosecuted. He said what the Kiwanis Club did tonight moved him. Lastly, he said he loves the Whitehall Rams and looks for every opportunity to celebrate our kids.
