# MINUTES – April 9, 2024

President Potter called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, April 9, 2024.

At President Potter's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

Mayor Bivens told how the Martin Luther King Scholarship began. He and Councilperson Elmore are elated to see how much the scholarship has grown and to see all of the young people who are still participating. He and Superintendent Wells have been collaborating and just to see them there tonight. Not only are they their wildest dreams, but also those of their parents and grandparents. They are the wildest dream of Martin Luther King Jr, who could never have imagined or thought about the day that young people like them not only come to school but matriculate through high school to be successful and to have all of the testimonies they are going to have as it relates to going to college. He congratulated them again and he is honored to do it. He will do it again next year.

At this time, there was a brief recess to allow the students and families to gather their computers and exit the Council Chambers.

#### OFFICIALS' REPORTS

Mayor Michael T. Bivens – tomorrow officially marks the one-hundredth day. He understands that some of them will not be able to attend as they have other commitments. He thanked his staff and everyone for getting it together. He is excited. He congratulated Parks and Recreation Director Shannon Brady and Cory Ollie for a fantastic event at John Bishop Park. The Solar Eclipse Party was well attended. He thinks the community was well impressed by the love and camaraderie but then the eclipse was just the icing on the cake.

City Attorney Bradley S. Nicodemus –thanked the Mayor and Council President for last Tuesday during the severe weather forecast for taking the precautions to keep everyone safe. Last week, he and Kylie Keitch spent the afternoons with the Police Department updating them on some training. It is always good to see the officers when they are not in the field having to make decisions. He asked for favorable consideration on Resolution 009-2024.

City Auditor Steve Quincel – he is seeing some decent activity within the Tax department. Income tax revenue is up for this point in the year from last year. They are up a little over twelve percent. That has to be tempered with the income tax refunds that are being paid to folks who work remotely and those are also up by one-hundred and one percent. They have paid out almost one million dollars in income tax revenue so far this year. He asked for favorable consideration on Ordinances 024-2024, 025-2024, 026-2024 and 027-2024.

Director of Public Service Casey Thomas –is excited to look at the past one hundred days and to see what is coming. It is a great way for everyone to get out there and network. She asked for favorable consideration on Ordinances 016-2024, 017-2024 and 021-2024.

# ORDINANCE NO. 024-2024 was read by title only by President Potter:

MAKING A FUND TRANSFER IN THE AMOUNT OF SIXTY-SEVEN THOUSAND ONE HUNDRED TWENTY-TWO AND 27/100 DOLLARS (\$67,122.27) FROM UNAPPROPRIATED MONIES IN THE GENERAL FUND (101) TO THE DEBT SERVICE FUND (401) AND DECLARING AN EMERGENCY.

Mr. Morrison introduced and moved to suspend the rules on Ordinance No. 024-2024 and Ms. Heck seconded the motion.

Auditor Quincel explained this is a loan re-payment on work that was done on the energy upgrades at City Hall, the Police and Fire Department buildings and at the Service Department Garage.

On a roll call vote, all members voted in the affirmative and the rules on Ordinance No. 024-2024 were suspended.

Mr. Morrison moved to adopt Ordinance No. 024-2024 and Ms. Heck seconded the motion. There was no discussion. On a roll call vote, all members voted in the affirmative, and Ordinance No. 024-2024 <u>was adopted.</u>

## ORDINANCE NO. 025-2024 was read by title only by President Potter:

APPROVING AND MAKING A SUPPLEMENTAL APPROPRIATION OF FOUR THOUSAND AND NO/100 DOLLARS (\$4,000.00) FROM UNAPPROPRIATED MONIES IN THE FIRE DEPARTMENT GRANTS FUND (221) TO THE FIRE DEPARTMENT GRANTS RETENTION INCENTIVE ACCOUNT (221.000.50040) AND DECLARING AN EMERGENCY.

Mr. Morrison introduced and moved to suspend the rules on Ordinance No. 025-2024 and Mr. Brown seconded the motion.

Auditor Quincel explained they had received a grant for retention incentive for the Fire Department. One individual left the city's employment so they now need to return the monies.

On a roll call vote, all members voted in the affirmative and the rules on Ordinance No. 025-2024 were suspended.

Mr. Morrison moved to adopt Ordinance No. 025-2024 and Mr. Brown seconded the motion. There was no discussion. On a roll call vote, all members voted in the affirmative, and Ordinance No. 025-2024 was adopted.

# ORDINANCE NO. 026-2024 was read by title only by President Potter:

AUTHORIZING AND APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF SIXTY ONE THOUSAND TWO HUNDRED TWENTY EIGHT AND 60/100 DOLLARS (\$61,228.60) FROM UNAPPROPRIATED MONIES IN THE ENERGY PROJECT FUND (810) TO THE ENERGY PROJECT FUND EXPENSE ACCOUNT (810.000.50000) AND DECLARING AN EMERGENCY.

Mr. Morrison introduced and moved to suspend the rules on Ordinance No. 026-2024 and Ms. Harcar seconded the motion.

Auditor Quincel explained this is another loan repayment that is paid from property tax settlements. Money was received from Franklin County last week and now the bill is coming due.

On a roll call vote, all members voted in the affirmative and the rules on Ordinance No. 026-2024 were suspended.

Mr. Morrison moved to adopt Ordinance No. 026-2024 and Ms. Harcar seconded the motion. There was no discussion. On a roll call vote, all members voted in the affirmative, and Ordinance No. 026-2024 <u>was adopted.</u>

#### ORDINANCE NO. 027-2024 was read by title only by President Potter:

RECLASSIFYING A FUND ADVANCE AS A FUND TRANSFER AND DECLARING AN EMERGENCY.

Mr. Morrison introduced and moved to suspend the rules on Ordinance No. 027-2024 and Mr. Dixon seconded the motion.

Auditor Quincel explained that in 2022 an ordinance advanced monies from the General Fund to the Technology Fund. The Auditors informed him that he had missed on when he cleaned the others up at the end of 2023. They are simply making the advance a transfer, as the likelihood of the 314 Fund having thirty-five grand to advance back to the General Fund is highly unlikely.

On a roll call vote, all members voted in the affirmative and the rules on Ordinance No. 027-2024 were suspended.

Mr. Morrison moved to adopt Ordinance No. 027-2024 and Mr. Dixon seconded the motion. There was no discussion. On a roll call vote, all members voted in the affirmative, and Ordinance No. 027-2024 <u>was adopted.</u>

## RESOLUTION NO. 009-2024 was read by title only by President Potter:

A RESOLUTION AUTHORIZING THE CITY OF WHITEHALL TO JOIN THE CITY OF COLUMBUS IN A LAWSUIT AGAINST THE STATE OF OHIO TO UPHOLD THE HOME RULE AUTHORITY OF THE CITY TO PURSUE AND ENFORCE TOBACCO REGULATIONS AND DECLARING AN EMERGENCY.

Ms. Smith introduced and moved to suspend the rules on Resolution No. 009-2024 and Ms. Harcar seconded the motion. There was no discussion. On a roll call vote, Heck, Yes; Smith, Yes; Harcar, Yes; Dixon, Yes; Brown, Yes; Morrison, Yes; and the rules on Resolution No. 009-2024 were suspended.

Ms. Smith moved to adopt Resolution No. 009-2024 and Ms. Harcar seconded the motion. There was no discussion. On a roll call vote, Heck, Yes; Smith, Yes; Harcar, Yes; Dixon, No; Brown, Yes; Morrison, Yes; and Resolution No. 009-2024 <u>was adopted.</u>

#### POLL PUBLIC:

Joy Bivens, 4985 Doral Avenue said there is a twenty thousand dollar scholarship for high school seniors in Franklin County. They will distribute five vouchers, five thousand dollars a year over four years for college and technical schools. It is a humankind scholarship.
