WHITEHALL CITY COUNCIL MEETING

MINUTES – April 16, 2019

President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, April 16, 2019.

At President Graham's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the April 02, 2019, agenda and regular meeting minutes. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and the minutes were approved as submitted.

SPECIAL PRESENTATION

Dr. Tom Edwards, Exec. Director of Restore Whitehall gave a presentation on the progress of Restore Whitehall. He said Restore Whitehall is a community initiative dedicated to helping TANF eligible families residing in the City of Whitehall build the capacity to become holistically successful in the arenas of family unity, educational attainment, financial security and career advancement. During 2018, 110 head of household interviews were held, 60 students received tutoring support, 20 received parent training and 20 people participated in the soapbox derby STEM program. In 2019, the added focus will be on housing, health, and wellness. The length of time to complete the program is eighteen months to three years.

Dr. Tom Edwards answered question from city council members at this time.

POLL PUBLIC

Steven White, Vice President of Strategic Initiatives at C.O.S.I. thanked the City of Whitehall for its partnership. The mission and vision of C.O.S.I is to engage and transform lives in communities by being the best partner in science technology and industry learning. That critical partnership piece is very important. I just want to say thank you to the City of Whitehall for its partnership with C.O.S.I. around its Science Festival. May 1st thru the 4th is the date for the Science Festival. The festival is free because we recognize if we can deliver these opportunities to our communities in a way that makes them comfortable around science, technology and math then they grow.

Mr. White answered questions from city council members and administration at this time and gave all members of Council a C.O.S.I. t-shirt and pamphlet.

City Attorney Michael Bivens – he shared he had the opportunity to speak with the representative from the Columbus Urban League that helps facilitate the plea agreement program through the City of Whitehall Mayors Court. He learned that over five hundred individuals have been helped since this program has started in Whitehall's Mayors Court. He shared a story of a young man who has completed the diversion program and gone on to purchase a new home. He thanked the Mayor and City Council for believing in this program and he is looking forward to its continuance.

Mr. Savage stated his company manages the property located at 4210 East Broad Street. He stated that one time there was a drive-thru window that operated in that building so the facilities are already there. Recommendations given to us are that we restripe the drive-thru and put in a walkway for pedestrian to get from the parking lot to the restaurant. He asked if anyone has any questions.
