### Section 1-86: Gender-Neutral Language

- Gender- Neutral Language will be recommended to City Council to Review

### Sections 3(e), 23(b),26(b),41(b) and 45(b): Elections and Qualifications-Term Limits

- Move from two to three term limits for all elected positions
- Do away with term limits all together
- Kim Bentley had a thorough discussion about these sections moving from 2-3 terms.
- Paul Werther had recommendations for removing term limits all together.
- Regardless of what City Council decides to do, the language needs to be written clearly on the ballot since there was ample discussion how confusing the language was written on the ballot.

### Section 24(c): Mayor's Residence

- o Consider Paul Werther's recommendation for Council.
- The Mayor should always be a member of Whitehall.

### Section 50 (b): Non-Residents Board or Commission Representation

- Consider Allyson Sharp's recommendation and language for Council.
- o Board and Commission members should reside in Whitehall.

### Section 86: Ward Representation

- There should be representation from each Ward in Whitehall for future Commissions
- Consider Allyson Sharp's recommendation and language for Council.
- There was discussion on whether City Council Members must supply a certain number of names from the Wards they represent.

The Whitehall Review Commission has shared these recommendations with Council in a timely manner with Whitehall City Council who will make the final decisions. As the Chairperson, this has been an honor to serve. The rest of the Commission concurred.
