WHITEHALL CITY COUNCIL MEETING MINUTES – MAY 15, 2018

Council President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, May 15, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

EXCUSE ABSENT MEMBERS

Mr. Bailey moved to excuse the absent members and Mr. Rodriguez seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and Ms. Elmore was excused.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the May 1, 2018 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all present members responded in the affirmative and the Minutes were approved as submitted.

POLL PUBLIC

Gerald Dixon, 3877 Doney St. He explained the definition of bullying and that it is a citizen's first amendment right and their civic duty to point out mistakes with city officials. He stated he appreciates citizens filling a public duty, but they are still political appointees performing official duties. Therefore, they can be challenged on their decisions.

She will have legislation next week regarding the My Home Program. They have been having interviews with architects for the YMCA and they should be making a decision soon. They will be reviewing applications for CMR interviews.

City Attorney Michael Bivens – he thanked everyone for coming this evening. This Thursday, May 17 at 6:00 p.m. the Legal Rams will do their Mock Court Program at City Hall. The Mock Trial has become a part of the High School's curriculum and it is their final exam. The case for the Mock Trial is interesting to the kids because they have been seeing all the new construction in Whitehall. The question is if a Construction Manager can be held liable for murder as it relates to injuries or death to any persons that are on that property during the construction process. He invited everyone to come out to be a part of the jury. He thanked the mayor for coming to his wife's last school board meeting.

City Auditor Dan Miller – he had no official report. He asked for favorable consideration on Ordinance Nos. 041-2018 and 042-2018.

Director of Public Service and Development Zach Woodruff – he had no official report.

Director of Public Safety Van Gregg – was not present.

VERIFICATION OF COPIES

President Graham requested a roll call on whether each member of council received a copy of each item of legislation listed on the agenda prior to the meeting, including any add-on legislation. On a roll call vote, all present members responded in the affirmative.

THIRD READING:

ORDINANCE NO. 036-2018 was read by title only by President Graham:

"DECLARING THE IMPROVEMENT TO CERTAIN PARCELS IN THE CITY LOCATED AT THE SOUTHWEST CORNER OF THE INTERSECTION OF HAMILTON ROAD AND BROAD STREET TO BE A PUBLIC PURPOSE AND EXEMPT FROM TAXATION PURSUANT TO OHIO REVISED CODE SECTION 5709.40(B); PROVIDING FOR THE COLLECTION AND DEPOSIT OF SERVICE PAYMENTS AND SPECIFYING THE PURPOSES FOR WHICH THOSE SERVICE PAYMENTS MAY BE EXPENDED; AUTHORIZING SCHOOL COMPENSATION PAYMENTS; AND APPROVING A TAX INCREMENT FINANCING AGREEMENT AND A REVENUE SHARING AGREEMENT."

Mr. Bailey then moved to adopt Ordinance No. 036-2018 and Mr. Morrison seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and ORDINANCE NO. 036-2018 was adopted.

ORDINANCE NO. 037-2018 was read by title only by President Graham:

"AUTHORIZING THE EXECUTION AND DELIVERY OF A COMMUNITY REINVESTMENT AREA AGREEMENT BETWEEN THE CITY AND CONTINENTAL REAL ESTATE COMPANIES OR ITS DESIGNEE."

Mr. Morrison then moved to adopt Ordinance No. 037-2018 and Ms. Elmore seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and ORDINANCE NO. 037-2018 was adopted.

RESOLUTION NO. 015-2018 was read by title only by President Graham:

"RESOLUTION TO ADOPT A COMPREHENSIVE DEVELOPMENT PLAN THAT DESCRIBES THE PUBLIC NEED FOR THE PROPERTY KNOWN AS THE WOODCLIFF CONDOMINIUMS AND AFFIRMING THE PUBLIC NEED FOR THE PROPERTY AS NUISANCE ABATEMENT; AND AUTHORIZING THE MAYOR, ON BEHALF OF CITY COUNCIL, TO MAKE AN OFFER TO PURCHASE 317 PARCELS FROM THE WOODCLIFF CONDOMINIUM UNIT OWNERS ASSOCIATION."

Mr. Morrison then moved to amend Resolution No. 015-2018 and Mr. Bailey seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and RESOLUTION NO. 015-2018 was amended.

Attorney Bivens explained that this Resolution comes before the city after 11 years of litigation. On April 30, 2018 the former receiver and seven interested parties signed an agreement order to settle. In the order signed by Judge Hawkins and pursuant to the Condominium Association bylaws, all owners were given notice about the offer and a meeting was held. The meeting was held on May 14, 2018 at the Whitehall Library and the Condominium Association voted to accept the city's offer of \$8,866,220.80. They voted overwhelming to accept the offer by a margin of 172 in favor and 77 opposed.

Once council has adopted Resolution No. 015-2018, then the offer will be accepted by the appointed receiver on this matter. The agreed order also provides a process that any owner can object to the proposed distribution of proceeds. A distribution hearing has been requested and is set for some time in June. He reiterated that this settlement resolves nearly 11 years of litigation with the City of Whitehall. The city maintains that there are still some nuisance conditions remaining in the Woodcliff Condominiums, including defective drainage and plumbing resulting in unsanitary conditions. The city feels that the offer to purchase and the acceptance of that offer is a fair and final resolution to abate the Woodcliff Condominium property.

Mr. Morrison then moved to adopt Resolution No. 015-2018 and Mr. Bailey seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and RESOLUTION NO. 015-2018 was adopted.

SECOND READING:

"MAKING A SUPPLEMENTAL APPROPRIATION OF FIFTY-ONE THOUSAND AND 00/100 DOLLARS (\$51,000.00) ONE HUNDRED ELEVEN THOUSAND AND 00/100 DOLLARS (\$111,000.00) FROM THE ECONOMIC DEVELOPMENT INCENTIVES/PLANNING FUND (316) TO ECONOMIC DEVELOPMENT INCENTIVES EXPENSE ACCOUNT (316-000-50000) AND DECLARING AN EMERGENCY."

"AUTHORIZING THE MAYOR TO OFFER A CANDIDATE FOR EMPLOYMENT EXCEPTIONS TO 161.15(a) FOR THE PURPOSE TO PERMIT THE USE VACATION LEAVE DURING THE FIRST SIX MONTHS OF HIRE, 161.12(b)(1) TO ACCEPT PRIOR PUBLIC SERVICE ELIGIBILITY AND EXPERIENCE IN REGARD TO EARNED VACATION LEAVE COMPUTATION IN THE RANGE OF 9-12 YEARS PER 161.15(b)(1) AND DECLARING AN EMERGENCY."

Mr. Bailey introduced and moved to suspend the rules on Ordinance No. 045-2018 and Mr. Rodriguez seconded the motion. There was no discussion. On a roll call vote, all present members voted in the affirmative and ORDINANCE 045-2018 was suspended.
