City Attorney Michael Bivens – he thanked the audience for their attendance. He gave an update on his son who has discovered his love for shot put. The official report from the City Attorney's office is that during the month of April 2019, Whitehall Mayors Court prosecuted 294 cases with only 32 of those cases committed by Whitehall residents. On Thursday, May 23, 2019 at 6:00 p.m., the Legal Rams will be having their Mock Trial in the city hall courtroom.

City Auditor Dan Miller – he had no official report.

Director of Public Service and Development Zach Woodruff – he gave an update on the street program. The Yearling Road project is ahead of schedule. The street program came in not only under bid but also under contract. Work beginning on Fairway Blvd. should start in the next month. This project will be completed using the permissive tax fund. This represents about 3.8 million dollars spent this year on infrastructure.
