OFFICIALS' REPORTS

Mayor Kim Maggard – she thanked everyone for coming this evening. She commended Director Sorrell on the great job she did keeping the John Bishop Park playground on track. They thanked all the public officials that came to the great ribbon cutting event last night. Music in the Park started and will continue through August. There will be a rededication of Lamby Lane playground on Sunday, June 24 at 4:30 p.m. Look at the Parks and Recreation calendar for July because there are more opportunities to come celebrate Whitehall parks new developments.

City Attorney Michael Bivens – he thanked everyone for coming this evening. His official report for the month of May consisted of 332 cases in Mayor's Court, only 35 of them were committed by Whitehall residents. 96 cases were transferred to Franklin County Municipal Court, 23 of those cases were of a criminal natural from Whitehall residents. The total number of cases that the Whitehall Prosecutors Office handled in the month of May 2018 was 428.
