President Pro Tem Bailey called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, June 19, 2018.

At President Pro Tem Bailey's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

Mr. Rodriguez moved to excuse President Graham from the June 5 and June 19 City Council Meetings, Mr. Conison seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and President Graham was excused.

President Pro Tem Bailey reported that there will be no City Council Meeting on July 3, 2018 and that the July meetings will as follows; City Council Meetings will be July 10 and July 24 and Committee Meetings will be July 17 and July 31.

Administration and Financial Management – Mr. Rodriguez reported that they met last Tuesday and their minutes are on file and they will meet again next week, sometime after 6:30 p.m.

Community and Elder Advocacy – Chairperson Elmore reported they met last Tuesday and went over Resolution No. 025-2018. Their minutes are on file and they will meet next week, sometime after 6:30 p.m.

Community Standards and Enforcement – Chairperson Rodriguez reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Economic Development – Chairperson Morrison reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Infrastructure, Maintenance and Services – Chairperson Heck reported that they met last Tuesday and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Public Safety – Chairperson Conison reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Parks and Recreation – Chairperson Kantor reported that they met last Tuesday and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – she asked for favorable consideration on Ordinance No. 059-2018. She reported the city has been interviewing construction managers for the YMCA project and a decision will be made this week. The street crew is continuing to work on repairing and constructing new curbs on Broad Street and for everyone to be careful as it narrows to one lane. The fireworks viewing tickets are available at City Hall until June 29 from 8:00 a.m. to 4:00 p.m. in the Service Department. The festivities will begin at 6:00 p.m. on July 3 at Whitehall Yearling High School football stadium. The Independence Celebration Carnival begins on June 28 and runs through July 1 at John Bishop Park. The city has renovated the playgrounds at all the city's public parks for a total cost of \$750,000. There is a Ribbon Cutting Ceremony for the new Lamby Lane playground this Sunday at 4:30 p.m. Music in the Park is featuring British Invasion this week.

City Attorney Michael Bivens – he said his office has initiated what they call a strategic community incentive in respect to diversion. It is a plea bargain agreement that is done in Mayors Court in respect to diverting cases that are poverty related or low level drug cases. They use the Urban League to do this. The Columbus City Attorney has noticed what Whitehall has been doing and is interested in the program. Most of the cases in Whitehall Mayors Court are committed by Columbus residents. Therefore, if we can help Columbus, we will help Whitehall. The Urban League will be holding a program called "Empower You" at Whitehall City Hall on Thursday, June 28 from 9:00 a.m. to 5:00 p.m.

He updated council and the public regarding the ongoing problem with Roses Parking Lot. He said Code Enforcement has sent numerous violation letters regarding the potholes in the parking lot. The violations have been ignored because the owner lives in California. The City Attorney's office is going to start using other resources to escalate this issue. He is asking if anyone has had damages to their car or any other personal experience from the condition of this parking lot, please contact the City Attorney's office. Once they collect the facts they are going to make sure the property owner does what he is obligated to do.

City Auditor Dan Miller – he said today they wrapped up the 2017 Audit. He asked for favorable consideration on Ordinance Nos. 055-2018 and 056-2018 and Resolution No. 024-2018

Director of Public Service and Development Zach Woodruff – he thanked the City Attorney's office for taking on the issues of Roses Parking Lot. He said Code Enforcement staff has been working on this issue for years and they can only do so much. The street crew is working on curbs, sidewalk panels and storm drops along Broad Street. The city has seasonal people to help with weeding and mowing. He appreciates all the support.

Director of Public Safety Van Gregg – was not present.

Treasurer Steve Quincel – he had no official report. He congratulated his 87 year old father, Robert Quincel who through the efforts of the Franklin County Veterans Services Office and Columbus Board of Education was awarded his South High School Diploma.
