COMMITTEE OF THE WHOLE

RESOLUTION NO. 019-2020 – Draft # 1

ADOPTING THE TAX BUDGET FOR THE CITY OF WHITEHALL, OHIO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2021 AND SUBMITTING SAME TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY.

Mayor Maggard said on July 7, 2020 the City will present a plan to Council regarding flood mitigation and how they are going to help the residents. Mitigation will be in the form of providing relief for sewer back-ups in the basements. Probably in a couple of weeks she will have legislation regarding the Local Waste contract beginning in 2021. Regarding Draft # 1, Resolution 019-2020, the tax budget, please know the way the state law reads is that whatever was appropriated by Council for January 01, 2020 is what has to be put into the tax budget. She believes that everyone realizes that is no longer applicable to the City of Whitehall due to the decrease in revenues due to covid-19. It need to be done soon because the State's budget cycle is different from the City's. The City's begins January 01 and the State does theirs in the middle of the year. The City Auditor included some revenue that is coming in for bond proceeds, which is bond monies the City are going to receive to pay bonds with. He put it in the general fund but really that is going to the 402 fund. She talked with the Auditor and they agreed that because it is not general fund monies that can be used it will need to be accounted for in its own fund. This has not been changed on this tax budget yet. It looks like there is a lot of money there than we actually have. She just wanted to let Council know that 1.) we had to use what was appropriated, even though we do not have it and 2.) the Auditor included money that will be put into a different fund. She believes the Auditor wants this Resolution passed on first reading. She thanked Council on their consideration on the tax budget so it will allow the City to get their local government funding. If it is not turned in on time the City will not receive any money from the state.

ADMINISTRATION AND FINANCIAL MANAGEMENT

APPROVING AND MAKING A FUND TRANSFER IN THE AMOUNT OF THREE HUNDRED TWENTY-THREE THOUSAND NINE HUNDRED ELEVEN AND 49/100 DOLLARS (\$323,911.49) FROM UNAPPROPRIATED MONIES IN THE GENERAL FUND (101) TO THE ECONOMIC DEVELOPMENT INCENTIVES FUND (316) AND DECLARING AN EMERGENCY.

Mayor Maggard said these are incentives that the City and Council have agreed to in the past and theses are payments that need to be made to different businesses throughout the year. The City has some incentives due in July and they have performed better than expected.

Chairperson Morrison asked if they could get a list of the companies and the incentives to be paid.

Mayor Maggard said she would ask Director Woodruff to provide Council with a list.

Chairperson Kantor asked if this piece of legislation has to be passed on first reading.

Mayor Maggard said that Director Woodruff has asked for the legislation to be passed on first reading.

President Potter said if he understands correctly, these are agreements made with the businesses and the City is contractually bound to pay this money. City Council passed legislation and these funds will need to be paid because they contractually agreed to it. He could see the sensitivity with this amount of money with everything else going on.

Mayor Maggard said for Council to remember these businesses has performed accordingly as they said they were going to with regard to how much money they have paid for income tax in 2019 so it is owed to them in 2020.

President Potter said that it could be possible when we are looking at next year it could be a potentially significantly lesser number.

Mayor Maggard said let's hope not but it could be.
