President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, July 24, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the July 10, 2018 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and the Minutes were approved as submitted.

Parks and Recreation – Chairperson Kantor reported that they met two weeks ago and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – she had no official report. She expressed her sadness on the passing of Chuck Underwood. She said that Chuck Underwood held many positions for the City of Whitehall which included Board of Zoning, City Attorney, City Councilman, City Council President, City Treasurer and most recently Safety Director. Not only did he serve in many capacities for the city, he was also a decorated veteran. In the first Iraq war he flew bombers and logistical planes. He was also an instructor with FlightSafety, he heard appeals for Ohio Unemployment Compensation and he was a hearing officer for Financial Security. She said these are the things that she knew he did, but she is sure he did even more then what she shared. He was a compassionate, kind and a true friend. He was a mentor and he will be greatly missed. She is glad he got to spend his last days at his summer lake house that he loved.

City Attorney Michael Bivens – he thanked everyone for coming this evening. He thanked the mayor for the beautifully spoken words that were said about Chuck Underwood. He said Chuck was a fine individual and a fine human being and he will be missed.

His commended the mayor for her vision and the seed she planted for going after and receiving the opioid fund grant for the city. He said the mayor was not able to attend the event last week because she was on vacation, but she would have been proud of Sam Quinones and the efforts of Chief Menapace. There were over 300 people that came out that night as it related to the opioid epidemic. The community is interested and concerned about how the city is working hard to help the problem. Part of the grant is a pilot Mayors Drug Court and it will start August 14. It will be held at the Police Department and will run concurrent with our regular Mayors Court. They will be selective on who will be chosen for drug court because the grant only services 20 to 30 individuals for a two year period. Once someone is selected they will get the help they need to fight the addition. He feels the community will really benefit from this program.

Mayor Maggard added that the reason why they were able to have Mr. Quinones come and speak was due to the generosity of the Police Department and their training budget. The Fire Departments training budget was stretched and there was no money from the grant budget. She thanked the Police Department and said this is an example of complete team work.

Director of Public Service and Development Zach Woodruff – was not present.

Director of Public Safety Van Gregg – was not present.

Treasurer Steve Quincel – he had no official report.
