OFFICIALS' REPORTS

Mayor Kim Maggard – asked for Council's support on the passage of Ordinance 059-2020 on the first reading and she also wanted to let everyone know that she supports Resolution 025-2020 for the Whitehall Police Department. She gave a short synopsis of the budget situation. They are behind in income tax from July 31, 2020 to 2019. They are a bit behind. Currently for the budgeted revenue in income tax, they are 2.5 percent behind overall and for our total general fund they are down 3 percent for budgeted revenue. They are working really hard to stay on task to make sure they have a successful year.

AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT FOR THE COLLECTION, TRANSPORTATION AND DELIVERY FOR DISPOSAL OR PROCESSING OF RESIDENTIAL SOLID WASTE, RECYCLABLE MATERIALS AND YARD WASTE GENERATED WITHIN THE CITY OF WHITEHALL, FRANKLIN COUNTY, OHIO BETWEEN THE CITY OF WHITEHALL AND LOCAL WASTE SERVICES, LTD. AND AMENDING THE CODIFIED ORDINANCES OF THE CITY OF WHITEHALL, OHIO TO ENACT SECTION 933.15 SOLID WASTE AND RECYCLING COLLECTION SYSTEM ADMINISTRATIVE AND OPERATIONAL FEE FIXED RATE.

Ms. Conison introduced and moved to suspend the rules on Resolution No. 025-2020 and Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all members voted in the affirmative and Resolution No. 025-2020 was suspended.

AUTHORIZING A MASTER DEVELOPMENT AGREEMENT WITH NR INVESTMENTS OR ITS AFFILIATE TO PROVIDE FOR THE REDEVELOPMENT OF APPROXIMATELY FIFTY ACRES OF PROPERTY IN THE CITY COMMONLY KNOWN AS WOODCLIFF AND A PORTION OF THE ADJACENT WHITEHALL COMMUNITY PARK IN ORDER TO ELIMINATE BLIGHT, CREATE NEW HOUSING OPPORTUNITIES, AND CREATE AND PRESERVE JOBS AND EMPLOYMENT OPPORTUNITIES IN THE CITY; AND DECLARING AN EMERGENCY.

She wants them to know she appreciates every single one of them. She has had interaction with a few of them in regards to the patrolling they do around Robinwood and Doney. She has spoken to them. She has seen their interactions with the kids. She appreciates that because it takes a village to raise a child and they have really stepped and started to do exactly what people talk about. She also wanted to talk about the appreciation and the effort, the leadership and the unwavering commitment that they have to their jobs. She knows it is difficult and they work long hours. It doesn't go unnoticed. She sees them driving down the street and she waives and she appreciates just seeing them around. She thanked them and told them to continue to do their job, continue to support them as they continue to support each other and they will be a better community and city because of it. Ms. Conison thanked everyone that is viewing on Facebook. She wanted to thank everyone for coming there tonight. She had no idea that there would be this many people. She said it was her pleasure to prepare this resolution. She was given a lot of great information by her City Council members to put into the resolution. There was so much more that she could have written for that resolution. There is so much that they do that people don't see. She gets to see the times they are playing football in the street with some of the youth, giving biscuits out to some of the dogs, you are putting your hand in your pocket for money for homeless people or you are paying for things over at Walgreens because someone did not have the money. She sees and hears the things that they do and she is so proud to be the chairperson of public safety. She thanked them again.

He hears it all the time from neighbors, the increase patrolling in his area, they notice it. They are thinking about you and they care. What they do is not for the money, it can't be, it has got to be something deeper and he appreciates it. They do a wonderful job.

President Potter thanked Ms. Spicer for her very kind letters. Those are very much appreciated. He thanked everyone who tuned in from home and he thanked all the Officers who were able to be there this evening. It is a great show of numbers and they appreciate it and also the Officers who could not make it. Your dedication and commitment has never wavered since day one. He had a chance to visit with some of the Officers last week and especially with everything that is going on, it certainly has ramped up the level of responsibility in your position and to keep doing the wonderful job they are doing in keeping it all in check in here. He knows that is just how they were raised. It is not said often enough how much they are appreciated and he thinks collectively, unintentionally, it gets taken for granted but never think for one moment that they are not appreciated or valued or thought very highly of. Please know, from this Council and this Administration, we have your back.

Having nothing further, Mr. Bailey moved to adjourn and Ms. Elmore seconded the motion. On a roll call vote, all members responded in the affirmative and the meeting adjourned at 7:34 p.m.
