COMMUNITY DATE BOARD:

Chairperson Elmore said on Saturday, August 22, 2020 from 11:00 am to 2:00 pm Compassions Way in Partnership with the Whitehall Police Department will hold an event at the Etna Road parking lot at John Bishop Park. It is first come first served. They will be serving hamburgers and hotdogs. Beginning August 18, 2020 Franklin County will begin spraying for mosquitos. Whitehall Community Park will be closed August 17, 2020 until August 21, 2020 for maintenance of trees, water line replacement and Whitehall Police K-9 training.

POLL COUNCIL:

Ms. Elmore thanked all those that are viewing on Facebook. A resident shared with her that last Wednesday at John Bishop Park social distancing and face masks were not see. Whitehall has a mask mandate and it is not being followed. Why are we not following through with that was the persons question? The second thing is when are we putting the basketball nets back up at the park? Another resident asked why there are no handicap ramps around the Etna/Country Club/Fairway area? She told them that she would bring their concerns forward. Saturday, August 29, 2020 Franklin County Jobs and Family Services in partnership with the Urban League will be hosting a Safe Saturday event for kids and their parents where safety regulations will be explained and book bags and goodies will be given to identify them as a member of the Safe Saturday program. Megan Myer spoke about this last Tuesday and she just wanted to reiterate that this was something that would be coming forward as well. She reminded everyone to register to vote and to request your absentee ballots soon and turn those back in as soon as possible. There are still census takers in the area and it is still not too late to get your information out there.

Mayor Maggard said the handicap ramps have not been bid out yet and given that 2020 has been a difficult year, she understands why the bid process has not taken place. As for her order for masks, it expired on July 31, 2020 and Governor DeWine's order was in place. There was no need for two orders. People are to be social distancing and wearing masks but sometimes that is not happening, unfortunately.

Megan Myer said that the Safe Saturday event is being promoted for the kids that are selling water and you will not see this on social media. The tentative time is noon until 2:00 pm at the loading dock area behind Target.

Ms. Conison thanked everyone for viewing and wants everyone to stay safe.

Mr. Kantor wanted to thank all those watching tonight. He thanked Mayor Maggard for looking into the geese problem on Ross Road. He was made aware of this issue and he spoke with the Mayor and he knows she will look into things and they will discuss it next week. Councilperson Elmore mentioned the basketball hoops and when they may be put back up. He will call Director Sorrell and get back to them but he does not believe they will be going back up for a while. As far as the masks at John Bishop Park, he has been over there numerous times and he has walked that park along with Councilperson Morrison. He knows it is not perfect but they do a really good job and he is proud of the job Bob Straight and his staff have been doing. He just wanted to put that out there because they have done a good job in getting this league together at the last moment without charging the families. Safety is number one. He wished his son Michael a great first day at Otterbein. This is his senior year there.

Ms. Heck thanked all those watching from home and she thanked Amy for writing in and commending our Police Officers for doing a good job.

Mr. Morrison thanked all those watching from home and hopes everyone has a safe week.

Mr. Bailey hopes everyone has a great evening.

Mr. Rodriguez thanked Amy for the letter about the Police Officers. This reminded him to say thank you to the people over at the Fire Department for the help when his grandson Jackson was injured last week. Our fire and safety forces are second to none. They are just awesome.

President Potter thanked Amy for her letter. He thinks this is very nice reinforcement for our safety forces. He thanked everyone for viewing tonight and hopes everyone has a safe week.
