WHITEHALL CITY COUNCIL MEETING MINUTES – AUGUST 21 2018

President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, August 21, 2018.

At President Graham's request, everyone rose for a moment of silence. The Pledge of Allegiance was then recited by those assembled.

On roll call by the clerk, the following members of council were present:

APPROVAL OF MINUTES

Ms. Conison moved to approve the Minutes of the August 7, 2018 agenda and regular meetings. Mr. Kantor seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and the Minutes were approved as submitted.

SPECIAL PRESENTATION

Mayor Maggard thanked the Whitehall Community Police Citizens Academy Alumni Association for everything they do for the city. She stated that the WCPAAA is a group of volunteers that donate their time to make the city a better place. Not only are they at every event and activity the city has, they also patrol the neighborhoods to make sure the residents are taken care of. For 22 years, they have supported the City of Whitehall and the citizens of Whitehall. She asked the WCPAAA officers to come forward and presented them with a Certificate of Appreciation.

POLL PUBLIC

Gerald Dixon, 3877 Doney St. He thanked WCPAAA for everything they do. He stated that in last week's council meeting there was a discussion on legislation involving vendors and solicitors. Ms. Elmore asked if this included canvassers and she was told no. If that is the case, he is confused on the language that reads; provisions of the Do Not Knock Registry do not apply to persons invited onto the property by the occupant of those premises, for the purposes of peddling, soliciting or canvassing. He is asking for clarification on what it means to be invited on to the premises.

Allen Eble, 229 Fairway Blvd. He has lived on Fairway Blvd. for 30 years and he is asking for help on how to slow traffic down on Fairway. He has had to jump out of the way several times and he watches other people go through the same thing. He feels this is a serious problem and he is asking council to do something before someone is killed.

Mayor Maggard said she appreciates Mr. Eble's comments and wants him to know that they are concerned and are working on it.

President Graham said it has been a topic of conversation with council and administration. The police are trying to do something about it, but it is hard to have a patrol car parked on a street all day when other things are happening in the city. They are all trying to come up with a solution.

Ms. Elmore explained that she has had a conversation with Director Woodruff and the speed study is being conducted. They need to get some data to see how to proceed. She thanked Mr. Eble for coming to meeting and sharing his concerns. She said that other neighbors are also concerned.

STANDING COMMITTEE REPORTS

Administration and Financial Management – Chairperson Bailey reported that they met last Tuesday and their minutes are on file. They have many Ordinances that will be introduced tonight. They will meet again next week, sometime after 6:30 p.m.

Community and Elder Advocacy – Chairperson Elmore reported they met last Tuesday and their minutes are on file. They will meet next week, sometime after 6:30 p.m.

Community Standards and Enforcement – Chairperson Rodriguez reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Economic Development –Chairperson Morrison reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Infrastructure, Maintenance and Services – Chairperson Heck reported that they met last Tuesday and their minutes are on file. They have two pending legislations and they will meet next week, sometime after 6:30 p.m.

Public Safety – Chairperson Conison reported that they met last Tuesday and their minutes are on file. They will meet again next week, sometime after 6:30 p.m.

Parks and Recreation – Chairperson Kantor reported that they met last Tuesday and their minutes are on file. He said two weeks ago, they had National Night Out at Community Park and it was the best venue they have ever had. He wishes they would have had better weather. They have four pieces of legislation tonight and they will meet next week, sometime after 6:30 p.m.

OFFICIALS' REPORTS

Mayor Kim Maggard – she congratulated WCPAAA for their service. She said she would like to answer Mr. Dixons questions regarding the canvassers. It is not against the law to canvass, however if someone has a do not knock or no trespassing sign, they should not come to that door unless they are invited. If there is a do not knock you can still put your item on the porch. If there is a no trespassing, then you should not go up to the door or step in the yard. This is for canvassing purposes, not for solicitation.

City Attorney Michael Bivens – he thanked everyone for coming this evening. He thanked WCPAAA and said he appreciates all the work they do and they help make the community strong. He said Whitehall's Drug Court started last Tuesday. He explained the process on how people are recommended for drug court. The opioid epidemic is real and the fight is real. He commended the mayor on being proactive and bringing drug court to the city.

He said a press release was released today regarding the Woodcliff Condominiums. The litigation has been going on for 11 years and he commended members of council and the mayor for continuing with this litigation for as long as they have. It takes good government to care about its residents, even when it is not popular. He read a few lines of the court order from Judge Hawkins. It reads; this is not an eminent domain action. This is a nuisance abatement case. The instant lawsuit has not dragged on for eleven years. During those eleven years, the development known as Woodcliff Condominiums has been under the control of four different court-appointed receivers. Dozens of parties have come and gone in and out of the lawsuit. Legal challenges have been reviewed on two separate occasions by the Court of Appeals. New parties continue to raise new questions. Now this unremitting proceeding has a third judge presiding over it.

Even if the Court found it preferable, this case cannot return back to square one. There is some finality in legal judgments. A declaration of public nuisance and an order to abate was issued in February and April 2008. Presently, this is the scope of the Court's inherent power and authority to enforce the judgment and order to abate the nuisance conditions at the Woodcliff Condominiums development.

A thorough review of the history of this case shows over a decade of work untold thousands in legal fees have poured into the effort to improve the conditions of the Woodcliff Condominiums. Yet, the nuisance conditions continue to persist. It has been over ten years since the injunction order that adjudicated the original claim as of this lawsuit was filed. There may very well be other actionable claims between the parties or even non-parties that spawn from the activities within the Woodcliff properties. However, those will need to be pursued outside of this lawsuit.

This is a nuisance abatement case, but this is not an ordinary nuisance abatement case. Extraordinary problems require extraordinary solutions. The court does not render the following decision frivolously, but history has shown that there is no other viable way to enforce the Court's order to permanently abate the public nuisance conditions at the Woodcliff Condominiums. Therefore, the Court now issues the following Order approving the sale of the entirely of the Woodcliff Condominiums property to the City of Whitehall.

City Auditor Dan Miller – he had no official report. He asked for favorable consideration Ordinance Nos. 074-2018 through 079-2018.

Director of Public Service and Development Zach Woodruff – he had no official report.

Director of Public Safety Van Gregg – he reported that the Fire Department is doing a great job promoting Safe Station program to help with this Opioid crisis. In July, they had over 200 people at an event at Kae Ave. Elementary. They had the author of "Dream Land" who spoke on a national level regarding the opioid crisis and Attorney Bivens described the new Drug Court. On two different visits, they had Vice Admiral Jerome Adams with the United States Surgeon General and Senator Rob Portman come to the Fire Department to discuss the Safe Station Program and Drug Court. He was told by Chief Menapace that 88 people have gone to Maryhaven Stabilization Center, 52% have completed their detox program and are on their way to recover. They are proud of the Fire Department and what they are doing.

Treasurer Steve Quincel – he had no official report.

President Graham – advised that the following Officials' Reports have been filed in the Council Office since the last meeting: The Treasurer's Investment Report for July 2018; The Treasurer's Activity Report for July 2018; and The Treasurer's Fund Reconciliation Report for July 2018.

Ms. Elmore thanked everyone for coming out and for everyone who is watching at home. She encouraged everyone to come to the meetings and to bring someone with them. By being at the meetings they can determine what are facts and what are rumors. She congratulated WCPAAA for 22 years and said they deserve to be recognized. She appreciates everything they do. She thanked Mr. Elbe for coming to the meeting and sharing his concerns. She stated they will continue working on a solution for the problem and that this administration is doing a wonderful job. They all want the best for the citizens and the city in economic growth.

President Graham thanked everyone for coming. He urged everyone to bring someone with them to the next meeting. He congratulated WCPAAA for the great job they do and he is glad they were recognized. He said everyone appreciates the time you take away from your families to be a part of the city's events. He stated he was one of the original people that was on council when they started discussing the concerns at Woodcliff Condominiums. At that time, it was strictly about nuisance abatement and nothing to do with economic development. After a period, one thing can lead to another, but that was not the original intent.

Having nothing further, Mr. Bailey moved to adjourn and Ms. Elmore seconded the motion. On a roll call vote, all members responded in the affirmative and the meeting adjourned at 8:03 p.m.
