WHITEHALL CITY COUNCIL MEETING

MINUTES – September 03, 2019

President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, September 03, 2019.

At President Graham's request, everyone rose for a moment of silence. Those assembled then recited the Pledge of Allegiance.

Mr. Kantor moved to excuse the absent members and Ms. Conison seconded the motion. There was no discussion. On a roll call vote, all members responded in the affirmative and Mr. Bailey and Ms. Elmore was excused.

SPECIAL PRESENTATION:

Mayor Kim Maggard, presentment James with a Proclamation for Childhood Cancer month. James introduced his family.

Doris Calloway, Committee 4 Children Community Outreach Coordinator, Franklin County Children Services, 855 W. Mound Street, Columbus, OH 43223. She said Franklin County Children Services helps more than 30,000 abused, neglected and dependent children each year. About 67 percent of their operations are funded by two, 10-year property tax levies. One of those, a 3.1 mill levy, approved by county voters in 2009, will expire at the end of 2019. She did a presentation and shared some literature with council members. She asked Whitehall City Council for their endorsement of this levy.

She answered questions from Mayor Maggard and Mr. Kantor.

Mayor Kim Maggard – she asked for favorable consideration on Ordinance 101-2019, 102-2019, 103-2019, 106-2019 and 107-2019.

City Attorney Michael Bivens – he thanked the audience for their attendance. He said the official report from the City Attorney's office is that during the month of August 2019, Whitehall Mayors Court prosecuted 231 cases with 29 of those cases committed by Whitehall residents. That is about 12%. The combined total for Mayors Court and Municipal Court year to date is 2,835 cases with a large majority being traffic citations. He feels that some of the development that has changed the landscape and he will delve into the documentation to see what the factors may be for the increase in traffic citations for the Mayors Court cases. October the fifth, in partnership with ReStore Whitehall, will be doing the community give away again in recognition of Domestic Violence month. It is an open invitation to all residents. Donations will be accepted up until the morning of the event to the City Attorney's office. He asked for favorable consideration for Resolution 040-2019.

City Auditor Dan Miller – he had no official report. He asked for favorable consideration on Ordinances 105-2019 and Resolution 043-2019.

Director of Public Service and Development Zach Woodruff – he had no official report. He asked for favorable consideration on Ordinances 106-2019.

CITY COUNCIL MEETING – September 3, 2019

President Graham – advised there were no official's reports filed in the council office since the last meeting.

COMMUNICATIONS, PETITIONS AND CLAIMS:

PUBLIC HEARING:

RESOLUTION NO. 042-2019

A RESOLUTION AUTHORIZING THE MAYOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND / OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED AND DELCARING AN EMERGENCY.

President Graham opened the public hearing on Resolution No. 042-2019 at 7:17 p.m.

Development Director and Director of Public Service Zach Woodruff, 360 S. Yearling Road, Whitehall, OH 43213 said he and Ryan Andrews, EMH&T, 5500 New Albany Road, Columbus, OH 43054 were here to discuss their proposal for the next round of the Ohio Public Works Commission grant program. Director Woodruff said they are proposing this year's Ohio Public Works grant application to be for Poth Road. This would widen Poth Road to three lanes between Yearling Road and Hamilton Road. It will alleviate some of the congestion as you get to the intersection as well. It will also include new lights, curb and gutter and a multi-use trail down one side. As we have talked about the parks department connecting the Central Ohio's Greenways Trail down from Gahanna and Columbus, there is no good feasible way at this moment, to get over, under or around the railroad at Hamilton Road. The sidewalk under the railroad is not wide enough to put it there. It is difficult, if not impossible to do an at grade crossing cause they stack railroad cars there from time to time and obviously we are not doing some type of bridge over. It will probably cause the Greenways Trail to come down Hamilton Road, go west on Fifth Avenue to Yearling Road, use the on grade crossing the come down the south side of Poth Road to Poth and Hamilton Roads. If awarded, what we are applying for is a 75% grant and 25% loan. The 25% loan will be converted to an interest free thru OPWC for the useful life of the project, usually 18 to 22 years. This project is roughly a \$4,000,000.00 project.

A sign in sheet and comment forms were available for all those in attendance to fill out.

Director Woodruff and Ryan Andrews answered questions from President Graham and Chairperson Rodriguez.

After confirming there were no additional proponents or opponents, President Graham closed the public hearing at 7:27 p.m.
