OPWC, Issue 2 funding is typically a combination of grant, loan and/or local match for public infrastructure projects. It is funded by state gasoline tax and is a highly competitive application process. Applications are due by September 30, 2020 and public involvement is critical.

## **Budget Summary**

- Woodcliff Total Project Cost = \$4,244,962.00
  - Developer Contribution (25.1%) = \$1,065,486.00
  - OPWC Funding Request = \$3,179,476.00
- Broad/Hamilton Total Project Cost = \$10,923,278.00
  - State/Federal Contribution \$9,505,974.00
  - OPWC Requests \$1,417,304.00
  - OPWC would fulfill City's local match requirement.

Applications are due by September 30, 2020 Project selections are December 11, 2020 Funding available July 1, 2020
