City Attorney Michael Bivens – reported that the month of October is Domestic Violence Awareness month and they plan on giving two presentations at City Council meetings. The first presentation will feature the City Attorneys Victim Advocate. He said they have changed her title to become an Empowerment Advocate. Her goals are to empower victims of violence and to assist them through the process. This will give council and members of the public time to ask questions about her job and what she has done. Principal Smathers said that Candidates Night is a 100% student driven and student focused and these two ladies are the spokeswomen for the rest of the students.

Mr. Morrison thanked everyone coming. He said he appreciates the students coming and explaining how the Candidates Night will work. He is excited to be a part of it and he appreciates them hosting it.

Mr. Bailey thanked everyone for coming out tonight. He said to the students they did a tremendous job on presenting their event to council. He thinks it will be great and he can't wait to watch.

Mr. Rodriguez said it is good to see some new faces and the regulars. He said to the students they did a great job and he is looking forward to the event.

President Graham thanked everyone for coming out this evening. He said he hopes in the future we can do something else with the students and try to get many elected officials involved in it. He thinks it is important to get the younger people involved in their community. He stated that no one on council does this to make a living; they do it because they thought they should be involved and someone has to step up and do it.
