## WHITEHALL CITY COUNCIL MEETING

## MINUTES – October 01, 2019

President Graham called the regular meeting of Whitehall City Council to order at 7:00 p.m. on Tuesday, October 01, 2019.

## **APPROVAL OF MINUTES:**

## OFFICIALS' REPORTS

Mayor Kim Maggard – She said that the city is taking suggestions at this time on the type of public art people would like to see in the city. Your comments can be given to the city by sharing on the city's Facebook page. She invited everyone to do so if they so desire. She asked for favorable consideration on Ordinance 116-2019.

City Attorney Michael Bivens – He congratulated the Mayor on such a great event that was held at Heartland Bank last evening. He received many positive comments about it. He said the official report from the City Attorney's office is that during the month of September 2019, Whitehall Mayors Court successfully prosecuted 245 cases with 28 of those cases committed by Whitehall residents. That is about 11%. He reminded everyone that the month of October is Domestic Violence Awareness month and he thanked the city administration for having put out the purple flags along Yearling Road. Since taking office in 2016, the City Attorney's office has successfully helped or at least prosecuted 615 domestic violence cases. This Saturday, October 5, 2019 we are putting on, along with our partner Restore Whitehall, our annual swap meet. He thanked everyone who has made a donation this year.

City Auditor Dan Miller – he had no official report. He asked for favorable consideration on Ordinance 104-2019, Ordinance 114-2019, Ordinance 115-2019 and Resolution 048-2019.

Director of Public Service and Development Zach Woodruff – was not present.
