


# **GENERAL FUND REVENUES**





68% of revenue generated through local income tax Revenue increase over 2022 is due to bond proceeds and PT levy Water/Sewer Surcharge Revenue accounted for in capital accounts

# **GENERAL FUND EXPENDITURES**



\$3.1million budgeted for income tax refunds \$11.55 million transfer to capital accounts(\$8 million for police station project) Police, fire and EMS represents 32% of budget



# IMPACT OF THE PANDEMIC ON INCOME TAX

Slower tax growth (or slight decline) since pandemic

115% increase in income tax refunds as compared to before the pandemic



# **STAFFING SUMMARY**

- Funding for new six new officers, a new Network Security Administrator (hired in 2021) and a full time Social Media and Marketing Specialist (upgrading an existing part-time position started Q3 2023)
- 3.5% Non-union combined COLA and merit increase
- 2.5%-3% COLA for union members based on unit
- Major health insurance change in 2021 to high-deductible, Health Savings Account (HSA) model; Slightly higher HSA contribution compared to 2022 (4.5%)
