# JOB SUMMARY AND DISTINGUISHING FEATURES OF THE WORK:

The Whitehall Division of Fire provides fire, rescue, and EMS services for both the City of Whitehall and automatic response districts with the City of Columbus and all of its suburbs. Under the direction of the Fire Lieutenant and Fire Captain, the Firefighter engages directly in fire suppression, rescue, forcible entry, ventilation, salvage & overhaul, fire prevention, public service, community outreach, and emergency medical operations as required. The Division of Fire had approximately 6500 runs during the 2010 calendar year.

| 5          | A Firefighter/Paramedic shall have the ability to detect the origin of fire, recognize fires of a suspicious nature, preserve evidence, and report to his supervisor these findings, for further investigation by the Fire Prevention Bureau.   |           |

#### **IMPORTANT JOB FUNCTIONS:**

A Firefighter /Paramedic shall inspect, test, and maintain all city fire hydrants as required.

A Firefighter/Paramedic shall be familiar with the locations of all sprinkler and standpipe system connections. Be familiar with control valve locations and the basic operation of sprinkler and standpipe systems.

A Firefighter/Paramedic shall be familiar with the locations of all buildings equipped with elevators and the basic operation of the system at these locations.

A Firefighter/Paramedic shall have a good working knowledge of the current Fire Code of the City of Whitehall.

A Firefighter/Paramedic shall have a good working knowledge of the City Government and know the current elected officials and their function within the City.

A Firefighter/Paramedic shall, on occasion, be required to exercise supervision over other Firefighters in the absence of a superior officer and at other times as required.

A Firefighter /Paramedic shall be required to perform any other duties as assigned by a superior officer.
